

#### **Solutions**

#### S1. Ans.(b)

Sol. World Bank has projected the Indian economy to contract by 9.6 percent in the fiscal year 2020-21, in its Global Economic Prospects report. World Bank estimates Growth to recover to 5.4 percent in 2021.

#### S2. Ans.(c)

Sol. Uttar Pradesh-based Shivalik Mercantile Co-operative Bank (SMCB) has become the first urban co-operative bank (UCB) in India to receive licence from RBI to operate as a Small Finance Bank (SFB).

## S3. Ans.(a)

Sol. TheReserve Bank of India has introduced Legal Entity Identifier (LEI) for all payment transactions of value Rs 50 crore and above undertaken by entities (non-individuals) via Real Time Gross Settlement (RTGS) and National Electronic Funds Transfer (NEFT).

# S4. Ans.(b)

Sol. The New Development Bank (NDB) has signed loan agreements worth USD 646 million with the Government of India for two road projects in Andhra Pradesh.

Sol. A team of scientists from Japan is developing the world's first wood-based space satellite. This unique initiative aims to combat the growing problem of space debris or junk. The first satellite is scheduled to be launched in 2023.
