## The Most Important Current Affairs December 2021

### India's Harnaaz Sandhu crowned 70th Miss Universe 2021

Actor-model **Harnaaz Sandhu** made history as she was crowned **Miss Universe 2021** beating contestants from 80 countries, 21 years after India last brought home the title. While Paraguay's **Nadia Ferreira**, 22, finished second, South Africa's **Lalela Mswane**, 24, came third.

#### History of India in Miss Universe title:

Only two Indians before Ms Sandhu have won the title of Miss Universe – actors **Sushmita Sen** in 1994 and **Lara Dutta** in 2000. The 70th edition of the event was held in Eilat, Israel, where the 21-year-old bagged the coveted pageant.

#### Career of Harnaaz Sandhu:

The Chandigarh-based model, who is pursuing her master's degree in public administration, was crowned by her predecessor Andrea Meza of Mexico, who won the pageant in 2020. Ms Sandhu started her journey in pageantry when she won Times Fresh Face in 2017, representing Chandigarh at the age of 17. She later won the LIVA Miss Diva Universe 2021 title.

#### About the ceremony:

The ceremony was hosted by **Steve Harvey** and saw performances from American singer **JoJo**. The selection committee included actor and Miss Universe India 2015 **Urvashi Rautela**, Adamari López, Adriana Lima, Cheslie Kryst, Iris Mittenaere, Lori Harvey, Marian Rivera and Rena Sofer.

### RBI Monetary Policy: Repo rate unchanged for the 9th consecutive time

The **Reserve Bank of India's (RBI) Monetary Policy Committee (MPC)** headed by Reserve Bank of India (RBI) Governor **Shaktikanta Das** kept the repo rate unchanged at **4 per cent** for the **ninth consecutive time** while maintaining an 'accommodative stance' as long as necessary. The reverse repo rate will continue to be **3.35 per cent**. The central bank had last revised the policy rate on May 22, 2020, in an off-policy cycle to perk up demand by cutting the interest rate to a historic low. The meeting was held between December (6 to 8). The remaining will take place in **February (7 to 9, 2022)**.

### The Marginal Standing Facility (MSF) rate and bank rates remain unchanged:

- Policy Repo Rate: 4.00%
- Reverse Repo Rate: 3.35%

### RBI Monetary Policy Highlights & Key Decisions:

- The projection for real GDP growth is retained at 9.5% in 2021-22, consisting of 6.6% in Q3, & 6% in Q4. Real GDP growth is projected at 17.2% for Q1 of 2022-23 and at 7.8% for Q2 of 2022-23.
- The inflation projection was retained for FY22 at 5.3%, 5.1% for Q3, 5.7% for Q4, and 5% for Q1 FY23.

- A professor at the Mumbai-based Indira Gandhi Institute of Developmental Research: **Prof. Ashima Goyal**.
- A professor of finance at the Indian Institute of Management in Ahmedabad: **Prof. Jayanth R Varma**.
- An agricultural economist and a senior adviser with the National Council of Applied Economic Research in New Delhi: **Dr Shashanka Bhide**.

### World Inequality Report 2022 announced

France-based World Inequality Lab published its report titled “World Inequality Report 2022”. This report was authored by **Lucas Chancel**, who is the co-director of World Inequality Lab. It was coordinated by famed French economist **Thomas Piketty**. In 2021 the top 10 percent and top 1 percent of the Indian population hold 57 percent and 22 percent of total national income respectively, whereas the share of the bottom 50 percent has gone down to 13 percent.

### Key Findings analysis on inequalities in India:

- The report notes that the top 1 % of India’s population owns more than one-fifth of the total national income in 2021.
- The bottom half of the population earns just 13.1 per cent.

- It highlights that economic reforms and liberalization that India has adopted, have mostly benefited the top 1 per cent.
- The report identifies India as a poor and unequal country, with an affluent elite.
- 1 per cent richest people in India hold 22% of the total national income in 2021, while the top 10 % owns 57 per cent of the income.
- The average national income of the Indian adult population is Rs 204,200 in 2021, on the basis of purchasing power parity.
- However, the report clarified that the average national income of a country masks inequalities.

### The scenario in the world’s richest nation

The ratio in the richest nation that is the **US**, is **1 to 17**. The richest ten of the global population owns 52 per cent of global income. On the other hand, the poorest half of the population earns 8.5 per cent of the global income.

### Global Scenario

The Middle East and North Africa (MENA) are the most unequal regions in the world, whereas Europe has the lowest inequality levels. In Europe, the top 10 per cent income share is around 36 per cent, whereas in MENA it is 58 per cent.

### Indian Shuttler PV Sindhu won Silver at BWF World Tour Finals 2021

Indian Shuttler and 2-time Olympic medalist **Pusarla V Sindhu**, world’s number 7, won the silver at the **2021 Badminton World Federation(BWF) World Tour Finals**, officially known as the HSBC BWF World Tour Finals 2021. The reigning world champion PV Sindhu has won the BWF World Tour finals in 2018 and became the only Indian to achieve the feat.

## Argentina beat six-time champions Germany to lift Junior hockey world cup

**Argentina** showcased its organised game with great composure to beat six-time champion **German** side 4-2 and win the title after 16 years in the men's Hockey Junior World Cup at the Kalinga Stadium. Argentina has become the only third team after **Germany (six wins)** and **India (2001, 2016)** to win multiple Junior Hockey WC titles. Defending champions India finished fourth in the junior hockey world cup 2021 after losing 1-3 to France in the third-place match.

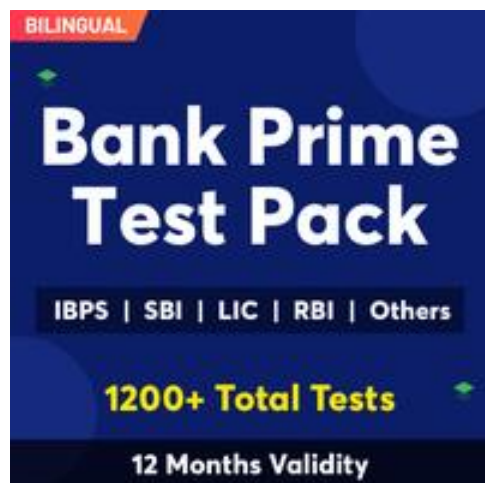

### Good Governance Index 2021: Gujarat topped the ranking

**Good Governance Index 2021** was launched by Union Minister **Amit Shah** on the occasion of the Good Governance Day on 25 December 2021. GGI 2021 was prepared by the Department of Administration Reforms and Public Grievances (DARPG). The GGI 2021 framework covered 10 sectors and 58 indicators. ### CEBR: India to become 3rd largest economy in 2031

The Centre for Economics and Business Research (CEBR) from the United Kingdom has predicted that the Indian economy will become the world's third-largest by the year 2031. In the year 2022, India is set to regain its sixth position in World Economic League Table (WELT) from France, as per CEBR.

In the year 2020, India's GDP had witnessed a contraction of 7.3% due to the COVID-19 pandemic and subsequent lockdown leading to constraints on economic activity. India has witnessed a large scale spread of infections and has the third-highest death toll worldwide, behind US and Brazil. However, with the help of emergency aid and prompt measures taken by the Indian government, the country has recovered from the second wave of COVID-19.

### In Global Scenario:

The annual league table also predicted that China will overtake the US to be the largest economy in 2030 (two years later than the forecast in 2021). The world economy is set to surpass \$100 trillion for the first time in 2022.

**NITI Aayog released 4th State Health Index**

NITI Aayog has released the **fourth edition** of the **State Health Index for 2019-20** that provides incremental performance in health outcomes and status. The index is developed by: NITI Aayog, World Bank, and Ministry of Health and Family Welfare (MoHFW). The report, titled **"Healthy States, Progressive India"**, ranks states and Union Territories on their year-on-year incremental performance in health outcomes as well as their overall status. The index is being compiled and published since 2017. The reports aim to nudge states/UTs towards building robust health systems and improving service delivery.

To ensure comparison among similar entities, the ranking is categorised as 'Larger States', 'Smaller States' and 'Union Territories':

- Among the 'Larger States', in terms of annual incremental performance, **Uttar Pradesh, Assam and Telangana** are the top three ranking states.
- Among 'Smaller States', **Mizoram and Meghalaya** registered the maximum annual incremental progress.
- Among UTs, **Delhi, followed by Jammu and Kashmir**, showed the best incremental performance.
- On overall ranking based on the composite index score in 2019-20, the top-ranking states were **Kerala and Tamil Nadu** among the 'Larger States', **Mizoram and Tripura** among the 'Smaller States', and **Dadra and Nagar Haveli and Daman and Diu and Chandigarh** among the UTs.

Her vegan kids' wear line, Ed-a-Mamma, also won a 2021 PETA India fashion award for helping to nurture kids' love for animals and nature. Alia also starred in a pro-adoption PETA India campaign to help cats and dogs. She has used her position to call for stronger animal protection laws.

- **India1 Payments** has crossed a milestone on deploying **10000 white-label ATMs**, which was called as **"India1ATMs"**. India1 Payments is IPO-bound and is promoted by the Banktech Group of Australia. It was formerly known as **BTI Payments**. India1 ATM has become the second-largest white label ATM brand on semi-urban and rural areas. With the deployment of 10000 ATMs, India1 Payments has become the largest player in this segment.
- **State Bank of India (SBI)** listed its **USD 650-million green bonds** simultaneously on the **India International Exchange (India INX)** and the **Luxembourg Stock Exchange (LuxSE)**. This dual listing is in line with 2021's topic of the **World Investor Week (WIW)**, 'sustainable finance', as indicated by the regulatory body International Financial Services Centres Authority (IFSCA). India INX has now emerged as the leading bond listing venue with over \$33 billion.
- Private sector lender, **Federal Bank** has launched a feature-rich savings bank product for women. The savings scheme is called **Mahila Mitra Plus** and provides a curated set of features, designed to make financial planning and investments easy for women.



- **IDFC FIRST Bank** announced the launch of **FIRST Private Infinite**, the country's first-ever standalone metal debit card, in partnership with Visa. FIRST Private Infinite is a lifetime free card designed specifically for customers who are part of the Bank's FIRST Private program, premium savings and wealth offering.
- **Punjab National Bank (PNB)** launched the **PNB Pride-CRMD module tool**, an android-based application for differently-abled employees to monitor and effectively follow up with the special mention account (SMA) borrowers. The Pride-CRMD module has built-in TalkBack software that allows the visually impaired to access the system freely and to interact with customers by tapping on their phones.
- **City Union Bank (CUB)**, in collaboration with **National Payments Corporation of India (NPCI)** and its manufacturing partner **Seshaasai**, has announced the launch of RuPay On-the-Go contactless wearable keychain for its debit card customers. - **Paytm Payments Bank** has been given the **scheduled bank** status by the **Reserve Bank of India**. The bank has been included in the Second Schedule to the **Reserve Bank of India Act, 1934** and the approval will help it to bring more financial services and products. - **Federal Bank** has entered into a **Bancassurance** partnership with **Star Health and Allied Insurance Co Ltd** as a corporate agent to provide health insurance products for the Bank's 8.90 million customers across India.
- The **Reserve Bank of India (RBI)** made **Legal Entity Identifier (LEI)** mandatory for cross-border transactions for capital or current account transactions of **Rs 50 crore** and above, from October 1 next year. The LEI is a **20-digit number** used to uniquely identify parties to financial transactions worldwide to improve the quality and accuracy of financial data systems.
- **Bank of Baroda (BoB)** has launched a solution for digital banking payments, named **bob World Wave**. Wearable technology is witnessing the rise of tremendous interest across the world and lenders are using this opportunity to adopt the more convenient and cashless digital payments systems. This is an innovative solution, intended to perfectly deliver preventive health actions as well as easier payment transactions.
- **Axis Bank** is working with new digital services from provider **Swift** to provide a comprehensive digital solution to clients. The bank is integrating with different digitization initiatives by government bodies and service providers to extend an end-to-end service to business clients.
- The **Reserve Bank of India (RBI)** has introduced a **prompt corrective action (PCA) framework** for large **non-banking financial companies (NBFCs)** with effect from October 2022, putting restrictions on para-banks whenever vital financial metrics dip below the prescribed threshold.
- The **Life Insurance Corporation of India** has launched a new non-linked, non-participating, individual savings life insurance plan called **Dhan Rekha**, it offers special premium rates for female lives. The plan is also allowed for the third gender adding that all benefits under the plan are fully guaranteed. There are special premium rates for female lives. The plan is allowed to Third Gender. All Benefits under the plan are fully guaranteed.
- A penalty of **Rs 1.8 crores** has been imposed on **Punjab National Bank (PNB)** by the Reserve Bank of India (RBI), while **ICICI Bank** has been fined **Rs 30 lakh** for deficiencies in regulatory compliances.

- **Reserve Bank of India**, in consultation with the Department of Financial Services, the Ministry of Finance, has decided to make the **Scheduled payments banks and scheduled small finance banks (SFBs)** eligible to conduct Government agency business. In May this year, RBI has revised the existing guidelines on '**Appointment of Scheduled Private Sector Banks as Agency Banks of RBI**' for authorising Scheduled Private Sector Banks as agency banks of RBI for conducting govt business (Central and/or State).
- **Equitas Small Finance Bank** has empanelled as the **banking partner** of the **state government of Maharashtra** with an aim to offer its services to employees of the State Government. The **Bandhan Bank, Karur Vysya Bank, and the South Indian Bank** have been assigned the role of distributing salaries and allowances to the government employees.
- **State Bank of India (SBI)** acquired a minority stake (less than 50 per cent) in **JSW Cement Limited** for an investment of **INR 100 crore** through **Compulsory Convertible Preference Shares (CCPS)**. The SBI is working as a strategic investor at JSW Cement and has invested in the company through CCPS. The conversion of such CCPS into common equity of the company will be linked to the JSW Cement's business performance and valuation at the time of the proposed initial public offering.
- **Bank of Baroda** has announced it has won the **#1 position** in overall digital transactions amongst large banks for FY20-21. The bank showed the exceptional growth of digital payment transactions achievement and was felicitated by the Ministry of Electronics & Information Technology (MeitY), Govt. of India at the **Digital Payments Utsav**.
- **Axis Bank** has announced the approval to reclassify **Oriental Insurance Company Ltd (OICL)** from promoter category to public category shareholder in the bank. In October, applications were made to BSE and NSE for reclassification of The New Oriental Insurance Co to the public category from the promoter category.
- **ICICI Prudential Life Insurance** became the first Indian insurance company to sign **United Nations-supported Principles for Responsible Investment (UNPRI)**, to demonstrate commitment towards the environmental, social and governance (ESG) issues. In order to promote sustainability, IPRULIFE is integrating ESG factors into its investment management framework. The UNPRI is an investor initiative in partnership with the two bodies of the United Nations – the UN Environment Programme Finance Initiative and the UN Global Compact.
- **Government of India and the Germany Development Bank- KfW (Kreditanstalt für Wiederaufbau)** signed a 26 million euros loan for a 40.35 km **Surat Metro Rail project** in Gujarat.
- **Central Bank of India and U GRO Capital** has signed a co-lending agreement and plans to disburse up to **Rs 1,000 crore** to medium, small and micro enterprises (MSMEs) over the next 12 months. The disbursement will be to U GRO Capital's varied MSME segments under its programs - **Pratham, Sanjeevani, Saathi, GRO MSME and machinery financing**.
- **Reserve Bank of India (RBI)** has announced the empanelment of **CSB Bank**, a private sector lender as an '**Agency Bank**'. Through this appointment, the CSB Bank will undertake the general banking business of the central and state governments under the guidelines set by the RBI.
- **Paytm Payments Bank** has partnered with **MoneyGram**, a peer-to-peer remittance company to enable international fund transfer directly to **Paytm Wallet**. Under the Partnership, MoneyGram users abroad can now transfer money to any full Know Your Customer (KYC)-compliant Paytm wallet. MoneyGram transactions in India received digitally stands at nearly 50 per cent of all transactions received in the country. This is MoneyGram's first mobile wallet partnership in India.
- **BOB Financial Solutions Ltd. (BFSL)**, a wholly-owned subsidiary of **Bank of Baroda (BoB)** and the **Indian Navy** have introduced a co-branded credit card for the personnel of the **Indian Navy**. The card will be equipped with contactless features and offered on the **RuPay platform**.
- **Reserve Bank of India (RBI)** has extended the **card-on-file (CoF) tokenization deadline** by 6 months i.e., to **June 30, 2022**. Earlier the deadline was fixed till **December 31, 2021**. In March 2020, RBI had issued guidelines for the regulation of payment aggregators and payment gateways, prohibiting payment aggregators and merchants to store customer card credentials within their database or server from 30 June 2021.
- **Reserve Bank of India (RBI)** has imposed monetary penalties on two payment system operators, **One Mobikwik Systems Private Limited** and **Spice Money Limited**, for violation of norms. Both the payment companies have been slapped with a fine of **Rs 1 crore**, as per the order issued by the central bank.

- **HDFC Bank** has signed an MoU with **India Post Payments Bank (IPPB)** to offer banking services to over 4.7 crore customers of IPPB in **semi-urban and rural areas**. Under the MoU, out of 4.7 crores, customers around 90 per cent reside in rural areas. The HDFC bank aims to boost its financial inclusion drive by leveraging IPPB's network of 650 branches and over 136,000 banking access points.
- **HDFC Life** signed a **bancassurance (Bank-Insurance)** agreement with **South Indian Bank** to enable customers of the South Indian Bank to avail HDFC Life's life insurance products and services to the customers of South Indian Bank. This bancassurance arrangement will enable customers of the South Indian Bank to avail HDFC Life's wide range of life insurance products which include solutions for protection, savings and investment, retirement and critical illness. This bancassurance partnership will further strengthen HDFC Life's business across India.
- **IndusInd Bank** has partnered with the **National Payments Corporation** to offer real-time cross-border remittances to India using UPI IDs, for its **Money Transfer Operator (MTO)** partners. It is the first Indian bank to go live on UPI for cross-border payments/NRI remittances.
- **IndusInd Bank** has announced the launch of '**green fixed deposits**', whereby the deposit proceeds will be used to finance projects and firms supporting the **UN's Sustainable Development Goals (SDGs)**. A green deposit is a fixed-term deposit for investors looking to invest their surplus cash reserves in environmentally friendly projects. These deposits will be offered to both retail & corporate customers.
- **Axis Bank** has become the **second-largest merchant-acquiring bank** in the country, leapfrogging two spaces during 2021 by installing over two lakh card-swipe machines during the year. This is part of the bank's '**Axis One**' strategy where it approaches the customers by offering its entire gamut of products instead of a standalone service.



## Economy Current Affairs

- Paris-based **Organisation for Economic Co-operation and Development (OECD)** decreased India's growth forecast to **9.4%** for FY22 from **9.7%** estimated in **September 2021**. It has projected the Indian economy to grow at **8.1%** in FY23, and moderate to **5%** in FY24. OECD lowered the global growth forecast for 2021 to **5.6%** from **5.7%** earlier.
- The rating agency, **India Ratings and Research (Ind-Ra)** expects **India's Gross Domestic Product (GDP)** in the Second Quarter of Financial Year-2022 (Q2 FY22) at **3 per cent** and in FY22 at **9.4 per cent**.
- The Singapore-based **DBS Bank's economic research team** has revised India's **FY23** growth forecast upwards to **7 per cent** year-on-year (y-o-y) (CY2022 **6.5 per cent**) from **6 per cent** earlier.
- **S&P Global Ratings** has retained the Gross Domestic Product (GDP) growth forecast of India unchanged at **9.5 per cent** for the financial year 2021-22 (FY22) and **7.8 per cent** for the year ending **FY23**. GDP growth projection of India was revised for FY 24 to **6 per cent** from **5.7 per cent** estimated earlier.
- Wall Street brokerage, **Goldman Sachs** has estimated India's GDP growth at **9.1 per cent** in **2022**. After India's economy contracted by a sharp **7 per cent** in 2020, Goldman Sachs pegged the economy to grow at **8 per cent** in 2021 and **9.1 per cent** in 2022. It earlier estimated India's economic growth to **11.1 per cent** in the fiscal year to March 31, 2022.
- **Fitch Ratings** has slashed India's economic growth forecast in the **financial year 2021-22 (FY22)** to **8.4 per cent** and raised the growth projection to **10.3 per cent** for **FY23**, compared to October 2021 rating projections of **8.7 per cent (FY22)** and **10 per cent (FY23)**.
- The gross **GST revenue** collected in the month of **November 2021** is **Rs 1,31,526 crores**. The **CGST** was **Rs 23,978 crore**, **SGST** is **Rs 31,127 crore**. The **IGST** was **Rs 66,815 crores** (of this **Rs 32,165 crores** was collected from the goods imported).
- **Asian Development Bank** has trimmed its 2021 growth forecast for India to **9.7 per cent** from **10 per cent** but left the 2022 growth forecast unchanged at **7.5 per cent**. The inflation forecast of developing Asia was revised to **2.1 per cent** for 2021 and unchanged at **7 per cent** for 2022.



- Producers' inflation based on the **Wholesale Price Index (WPI)** has reached an all-time high in the current series at **14.23 per cent** in November. This is the eighth successive month of double digits WPI (mainly due to the hardening of prices of mineral oils, basic metals, crude petroleum and natural gas). Wholesale Price-based Index (WPI) inflation base year is **2011-12**. Also, the spike is highest since April 2005.
- India** has registered the highest ever annual **Foreign Direct Investment** inflow of **\$ 81.97 bn** in **2020-21**. FDI inflows in the last seven financial years is over **\$ 440 bn**, which is nearly **58 %** of the total FDI inflow in the last 21 financial years. The top five countries from where FDI Equity Inflows were received during 2014-2021 are **Singapore, Mauritius, USA, Netherland & Japan**.
- According to the finance ministry, **advance tax collection** increased by **53.50 per cent** to Rs **4.60 lakh crore** so far this fiscal year, indicating a recovery in the economy. Direct tax collections for 2021-22, as of December 16, show that net collections are at Rs 9.45 lakh crore compared to Rs 5.88 lakh crore over the year-ago period, representing an increase of 60.8 per cent.
- Reserve Bank of India (RBI)** superseded the **Board of Directors of Reliance Capital Ltd (RCL)**, a Non-Banking Financial Company (NBFC), by exercising its power conferred under **Section 45-IE (1) of the RBI Act, 1934**. RCL is promoted by Anil Dhirubhai Ambani's Reliance Group. In this regard, the apex bank has appointed **Nageswar Rao Y** (Ex-Executive Director, Bank of Maharashtra) as the Administrator of the company under Section 45-IE (2) of the RBI Act.
- Paytm**, a leading digital ecosystem for consumers and merchants has partnered with **Amazon Web Services (AWS)** to offer **Paytm Startup Toolkit** with exclusive payment services to early-stage Indian startups. Paytm will help entrepreneurs to grow businesses with payment, distribution, and growth solutions who are operating in India in the AWS Activate.
- Phi Commerce's API (Application programming interface) first digital payments platform, **PayPhi** has become the **first certified tokenization service** for NTS supporting **tokenization of RuPay cards**. Tokenization of cards as an alternate to storing card details with merchants. NPCI's NTS platform enables PayPhi Tokenization service to provide partner merchants and aggregators with TROF. **Token Reference On File (TROF)** turns sensitive cardholder data into randomly generated 16 digit numbers called "token" with no meaningful value if breached.
- Bharti Airtel and Invest India**, National Investment Promotion and Facilitation Agency jointly launched '**Airtel India Startup Innovation Challenge**' for Startups to develop solutions in 5G, IoT. Under the Startup Innovation Challenge, early-stage technology companies are being invited to demonstrate differentiated solutions in areas such as 5G, Cloud computing, the Internet of Things (IoT), and digital entertainment.
- Life Insurance Corporation of India (LIC)** has received approval from the **Reserve Bank of India** to increase its stake to **9.99 per cent** in **IndusInd Bank** of the total issued and paid-up capital of the private sector lender. The approval will be valid for 1 year i.e., up to December 8, 2022.

### Business Current Affairs

- The **Asian Development Bank (ADB)** has approved a **\$500 million loan** to the Government of India to help improve the quality of the country's school education and mitigate the impact of the Covid-19) pandemic on students' learning. The loan supports the Integrated Scheme for **School Education (Samagra Shiksha)** and the new Exemplar School Initiative of the **Ministry of Education (MOE)** to improve education quality by focussing on inclusive and equitable learning outcomes.
- The **Reserve Bank of India (RBI)** has given its approval to **Life Insurance Corporation (LIC)** to raise its stake in private lender **Kotak Mahindra Bank** to **9.99 per cent**. Currently, LIC holds **4.96%** stake in the private lender. Kotak Mahindra Bank Limited has received an intimation from LIC stating that the RBI had granted its approval to LIC, for increasing its holding in the Bank up to 9.99 per cent of the paid-up equity share capital of the Bank.

- A leading private general insurer in India, **Bajaj Allianz General Insurance** has started its '**#Care4Hockey**' Campaign to elevate field Hockey's recognition in India. The company has partnered with Padma Shri (2020) **Rani Rampal**, Indian Women's Hockey Team Captain, who will be the face of the campaign. '**#Care4Hockey**' is a one of its kind campaign which aims to support the development of Hockey in India from the grass-root level.
- **Paytm**, which got listed in bourses last month, has announced the launch of **Paytm Wealth Academy**, a tech-powered educational platform. The launch of the wealth academy is initially on the **Paytm Money app**, the wealth management app owned by Paytm's wholly-owned subsidiary Paytm Money. Paytm Wealth Academy will initially be available to select users, followed by a complete rollout.
- Edtech platform firm **Adda247** has acquired UPSC-focused ed-tech platform **StudyIQ Education** for **\$20 million (150 crores)** in a cash and stock deal. Speaking on the acquisition, Adda247 founder and CEO **Anil Nagar** said it's a strategic acquisition for Adda247. StudyIQ Education has over 11 million subscribers on Youtube and the platform receives close to 100 million views a month, the company claims. The current acquisition will give Adda247 an edge in the UPSC segment.
- **WhatsApp** has announced the **Digital Payments Utsav for 500 villages in India**. WhatsApp's Digital Payments Utsav is a pilot program that promotes digital payments to empower individuals and businesses and is meant as a project to further the cause of financial inclusion. The aim is to empower villagers with access to digital payments via the '**payments on WhatsApp**'.
- **Asian Development Bank (ADB)** has approved a **Rs 2653.05 crore (USD 350 million)** policy-based loan to improve urban services in India. This loan supports the policies formulated by the **Ministry of Housing and Urban Affairs (MoHUA)** to benefit the urban poor, economically weaker sections, and low-income groups. ADB will also provide knowledge and advisory support to MoHUA in program implementation, monitoring and evaluation.
- The **Competition Commission of India (CCI)** has approved the acquisition of a shareholding in **Air India** by **Talace Private Limited**, a wholly-owned subsidiary of **Tata Sons**. The regulator also approved stake acquisition by Talace in Air India Express and Air India SATS Airport Services along with the acquisition of shares in Air India. Currently, Air India is wholly owned by the government.
- **Indian Oil Corporation Limited (IOCL)** has announced that it has acquired a **4.93 per cent** equity share in **Indian Gas Exchange Limited** - the country's first automated national level gas exchange. The Board of Indian Oil at its meeting held on 20 December 2021 has accorded approval for the acquisition of **36,93,750 equity shares** of the face value of **Rs. 10/-** each equivalent to 4.93 per cent of the share capital in **Indian Gas Exchange Limited (IGX)**.
- **Mastercard and Google** announced a **tokenization method** that enables Google Pay users to safely transact using their Mastercard credit cards and debit cards. With this collaboration, Google Pay Android users can scan and pay across all Bharat QR-enabled merchants, tap-and-pay, and make in-app transactions through their Mastercard debit and credit card.
- **Wipro** has signed an agreement to acquire **Edgile**, a transformational cyber security consulting provider, for **\$230 million**. Founded in 2001, Edgile is recognised by security and risk leaders for its business-aligned cyber security capability, deep understanding of the changing regulatory environment and enabling cloud transformations that help secure the modern enterprise. It has an onsite workforce of 182 employees.
- **State Bank of India** will acquire up to **9.95 per cent** stake in **India International Clearing Corporation (IFSC) Ltd** subject to a maximum investment of **Rs 34.03 crore**. The Clearing Corporation is a GIFT City (Gandhinagar, Gujarat) based Market Infrastructure Institution (MII).

## International Current Affairs

- **Barbados** has become the **World's newest republic**, around 400 years after it became a British colony. Barbados is said to have been made a '**slave society**' by the **British**. It first became an English colony in **1625**. It gained its independence in **1966**. Barbados, the Caribbean Island nation, removed Queen Elizabeth II as the head of the state.
- The former Finance Minister of Sweden, **Eva Magdalena Andersson** from the Social Democratic Party (SDP) won her **2nd election** and became the **1st female Prime Minister (PM) of Sweden**. On 24 November 2021, she was first elected as the PM but later resigned after her coalition partner (Green Party) quit the government and the budget failed to pass. Sweden's Parliament is known as **Riksdag**. Sweden is the last Nordic country to get a female Prime Minister.
- **US military personnel** and **Bangladesh Navy (BN)** began the **27th annual Cooperation Afloat Readiness and Training (CARAT) maritime exercise** virtually from 1 December in the Bay of Bengal. The nine-day exercise focuses on a wide range of naval capabilities and includes cooperative actions that demonstrate the US and Bangladesh's capacity to work together to ensure a free and open Indo-Pacific.
- **International Monetary Fund** Chief Economist, **Gita Gopinath** is set to take over from **Geoffrey Okamoto** as the institution's No. 2 official. The IMF has done some changes in the roles and responsibilities of the fund's senior management team. In which they introduced **deputy managing director** for the first time and it is gone to the first female named Indian born economist **Gita Gopinath**.
- The President of **Gambia**, **Adama Barrow**, won the second term as President during **Gambia's** presidential election by achieving over **53% votes** from 50 of 53 constituencies. He defeated his main challenger **Ousainou Darboe** who won **27.7% of vote**. The results of the election were declared by Electoral commission Chairman **Alieu Momarr Njai**.
- The **Biden administration** has announced that US officials will not attend the **2022 Winter Olympics in Beijing** after China pledged unspecified "**countermeasures**" against any such diplomatic boycott. The US cited that "**China's human rights ATROCITIES**" is the main reason for its boycott. The US has named the boycott as "**Diplomatic Boycott**".
- **German** lawmakers officially elected Social Democrat, **Olaf Scholz** as the new **chancellor**, putting an end to 16 years of conservative rule under **Angela Merkel**. He will lead a government composed of his Social Democrat Party, the business-friendly Free Democrats and the Greens, a coalition of parties never tried before at the federal level in Germany.
- **Canada** will join the **United States, the United Kingdom and Australia** diplomatic **boycott of the Beijing Winter Olympics** over human rights concerns. The announcement came after the White House, the Australian government and the UK government confirmed diplomatic boycotts of the Winter Games in February to protest Chinese human rights abuses. China has vowed to react with "**firm countermeasures**."
- **Myanmar's** ousted civilian leader, **Aung San Suu Kyi** was sentenced to **four years** imprisonment after being found guilty on two charges, the first verdicts in a raft of criminal cases that the country's military has brought against her since seizing power 10 months ago. Ms Suu Kyi was convicted of charges of incitement and violating pandemic rules. The 76-year-old Nobel Peace Prize laureate is facing a total of 11 charges which can bring in a maximum imprisonment of 102 years.
- The **United Arab Emirates** has announced to change its existing five-day workweek to a four-and-a-half day starting **January 1**, becoming the world's first country to make the employee-friendly transition as part of its efforts to improve productivity and work-life balance.
- US President **Joe Biden** has elevated Indian-American political advisor **Gautam Raghavan** as the head of the **White House Office of Presidential Personnel**. White House Presidential Personnel Office (PPO), also written as Office of Presidential Personnel, is the White House office tasked with vetting new appointees. The PPO is one of the offices most responsible for assessing candidates to work at or for the White House.
- **Dubai** became the world's first government to turn **100% paperless**, the announcement was made by the United Arab Emirate (UAE) Crown Prince, **Sheikh Hamdan bin Mohammed bin Rashid Al Maktoum**.
- **China** successfully launched a new group of satellites **Shijian-6 05** into space from the Jiuquan Satellite Launch Center in northwest China for space exploration and new technology tests. The satellites were launched by a **Long March-4B rocket** which marked the **400th** mission of Long March series carrier rockets.



- **Malta** became the first **European country** to allow limited cultivation and possession of cannabis for personal use, following a vote in parliament. The Maltese parliament voted in favour of the reform last week, with 36 votes in favour and 27 against.
- **Karl Nehammer** was sworn in as new **Austria's** chancellor by **Alexander Van der Bellen**, President of Austria in a ceremony in Hofburg Palace, Vienna, Austria. He is succeeding the career diplomat **Alexander Schallenberg** who took charge as chancellor in October 2021.
- 35-year-old, **Gabriel Boric**, has won Chile presidential elections, to become the youngest-ever President-elect of **Chile**. He defeated his opposition **Jose Antonio Kast** in the elections. Gabriel Boric will assume office in March 2022, will become the youngest president in Chile's history. Official results gave Mr Boric **56%** of the votes against Mr Kast's **44%**.
- **China** has launched a new satellite with a camera capable of taking photos of the ground with a resolution of five meters, according to the **National Space Administration of China (CNSA)**. The satellite, called "**Ziyuan-1 02E**" or "**Five Meter 02 Optical Satellite**".
- **Somalian** Prime Minister **Mohamed Hussein Roble** has been suspended. President **Mohamed Abdullahi Farmajo** has suspended the Prime Minister, who is facing allegations of involvement in the theft of land. Mohamed Roble accused the President of trying to stage a coup and said, he would continue in office.
- **Japan** has introduced a minibus lookalike world's first **dual-mode vehicle (DMV)** in its town of Kaiyo. The vehicle can run on normal rubber tyres on the road but its steel wheels, which are in its underbelly, descend when it hits the rail tracks. The DMV can carry up to 21 passengers and runs at a speed of **60km/h on rail tracks** and can go as fast as around **100km/h on public roads**.
- **Egypt** added as the fourth new member of **BRICS New Development Bank**. **Bangladesh, UAE, and Uruguay** joined BRICS New Development Bank in September 2021. Membership expansion enables New Development Bank to position itself as a premier development institution for emerging economies.

## National Current Affairs

- The **First Edition** of the **Indian Young Water Professionals Programme** was launched virtually. The program was taken up under National Hydrology Project. The India Young Water Professional Programme is unique and different from typical capacity building and training programs. It focuses on the engaged Training and Learning Model.
- **All India Radio** has decided to begin a new programme called **AIRNxt** to offer youth a platform to air their voices as part of the ongoing **Azadi Ka Amrit Mahotsav** celebrations. AIR stations will allow youngsters from local colleges, universities to take part in programming, allowing them to discuss and curate youth-centric shows.
- **International Telecommunication Union (ITU)** and the **Department of Telecommunications** operating under the Ministry of Communications conducted a **Joint Cyber Drill 2021**. The cyber drill was conducted for the **Critical Network Infrastructure operators of India**. The Critical Network Infrastructure are the systems, assets and networks that are essential to ensure the security of a country.
- **India and Bangladesh** have decided to celebrate **December 6**, the day on which India formally recognized Bangladesh, as "**Maitri Diwas**" (**Friendship Day**). During the visit of PM Narendra Modi to Bangladesh in March 2021 to attend the national day of Bangladesh, it was decided to commemorate 6 December as Maitri Diwas (Friendship Day). Ten days before the liberation of Bangladesh, India had recognised Bangladesh on **6 December 1971**. India was one of the first countries to establish bilateral diplomatic ties with Bangladesh.
- Ministry of Social Justice and Empowerment has formed a three-member committee to review the criteria for reservation for the Economically Weaker Sections (EWS) category in terms of the provisions of the explanation to Article 15 of the Constitution. The committee has been asked to complete its work within three weeks. Former Finance Secretary Ajay Bhushan Pandey will head the committee.
- The nation will have nine nuclear reactors by **2024** and a new nuclear project, the first in northern India, will come up **150 kms** away from **Delhi in Gorakhpur of Haryana**, the government informed the Rajya Sabha. By 2024, India will have nine nuclear reactors plus 12 new additional ones which were approved during the Covid times with a capacity of **9000 MW**.

- Union Minister of Information and Broadcasting **Anurag Singh Thakur** and Uttar Pradesh Chief Minister **Yogi Adityanath** inaugurated **Earth Station of Doordarshan Kendra** at **Gorakhpur**. Three FM stations of All India Radio were also inaugurated virtually on the occasion. This will be the second earth station of Doordarshan in Uttar Pradesh and it is being built at a cost of Rs.7 crore.
- Prime Minister **Narendra Modi** has inaugurated and laid the foundation stone of multiple projects worth **Rs 18,000 crore** at **Dehradun, Uttarakhand**. The 7 projects inaugurated consist of initiatives focusing on making travel safer including the 120 MW Vyasi Hydroelectric Project, along with Himalayan Culture Centre in Dehradun.
- Former chief election commissioner (CEC) **Sunil Arora** has been invited to join the board of advisers at the **International Institute for Democracy and Electoral Assistance**, also known as International IDEA. IDEA has a 15-member board of advisers, all of whom are eminent personalities from a wide variety of backgrounds.
- The **National Institution of Transforming India (NITI) Aayog** launched the '**e-Sawaari India Electric Bus Coalition**' in partnership with Convergence Energy Service Ltd (CESL) and World Resources Institute, India (WRI India) and with the support from Transformative Urban Mobility Initiative (TUMI). The objective of the initiative is to share knowledge of various stakeholders – Central & State Govt. agencies, transit service providers, original equipment manufacturers (OEMs), on accelerating the process towards seamless adoption of e-bus services in India.
- Union Minister of State for Education, **Dr Subhas Sarkar** has informed that the government is all set to launch **Bhasha Sangam** mobile app. The mobile app is developed to give users familiarity with common expressions of daily conversation in scheduled Indian languages. The app has **100+ sentences**, designed on different themes that allow people to learn basic conversation in **22 Indian languages**, test themselves and generate online certificates.
- **Ministry of Power** is celebrating the **Energy Conservation Week** from **8th to 14th December 2021** under "**Azadi ka Amrit Mahotsav**". Celebration by the Bureau of Energy Efficiency will include three major activities i.e. **National Painting Competition for school children**, **National Energy Conservation Awards (NECA) for Industries and establishments** and **National Energy Efficiency Innovation Awards (NEEIA)** to recognize innovative energy efficiency technologies.
- The **United Nations General Assembly (UNGA)** has granted Observer Status to **International Solar Alliance (ISA)** by adopting resolution 76/123. This decision has been taken based on the UNGA's Sixth Committee report. In November 2015, ISA was jointly launched by India and France during the 21st session of the United Nations Climate Change COP-21 in Paris, France to promote solar energy among its Member Countries.
- **India** assumed the Chairmanship of Council of **Regional Anti-Terrorist Structure of Shanghai Cooperation Organization (RATS SCO)** for 1 year from October 28, 2021.
- The **NITI Aayog** has planned to establish **1000 Atal Tinkering Laboratories** in **Jammu and Kashmir**. Out of 1000 Atal Tinkering Laboratories, 187 will be established by the end of the financial year 2021-22.
- **India** has been re-elected to **International Maritime Organisation (IMO) Council** for the **2022-2023** biennium under category B states. The Assembly of the International Maritime Organization has elected the Members of its Council for the 2022-2023 biennium.
- Prime Minister **Narendra Modi** has inaugurated the first phase of the **Rs 339 crore Kashi Vishwanath Corridor project** that connects the temple town's two iconic landmarks – **Kashi Vishwanath temple and Ganga ghats**.
- Union Minister Social Justice and Empowerment, **Dr Virendra Kumar** has launched **National Helpline against atrocities on SCs, STs**. The objective of the helpline, reportedly, is to build awareness about the provisions of the Act that are aimed at ending discrimination and providing protection to all. The Helpline will be available 24-7 on toll-free number – **14566**.
- Prime Minister **Narendra Modi** has inaugurated the **Saryu Nahar National Project** in **Balrampur, Uttar Pradesh**. The project will provide assured water for irrigation to over 14 lakh hectares of land and benefit about 29 lakh farmers, mainly in eastern Uttar Pradesh.
- Union Home Minister **Amit Shah** has laid the foundation stone of **Umiya Mata Dham temple** and temple premises under **Maa Umiya Dham Development Project** at Umiya Campus in Sola in **Ahmedabad, Gujarat**. They will be developed at a cost of **Rs 1,500 crore** on **74,000 square yards of land**.

- Union Minister of State (Independent Charge) Science & Technology, **Dr Jitendra Singh** inaugurated the seventh edition of the **India International Science Festival at Panaji, Goa**. The theme of the 4-day science festival is '**Azadi Ka Amrit Mahotsav**' - "**Celebrating Creativity, Science, Technology and Innovation for a prosperous India**". First India International Science Festival was held in 2015 at **IIT Delhi**.
- The proposal to raise the **minimum age of marriage for women from 18 to 21** was cleared by the **Union Cabinet**. Presently, the minimum age of marriage for men is 21 but for women, it is 18. The government will now look to introduce amendments to the **Prohibition of Child Marriage Act, Special Marriage Act, and the Hindu Marriage Act** to bring the plan into action. This will give a chance to the girls to study more. They will be able to enjoy their independence. They will also get better employment opportunities."
- Prime Minister **Narendra Modi** has laid the foundation stone of **Ganga Expressway in Shahjahanpur, Uttar Pradesh**. PM Modi also addressed a rally at Railway Ground, Rouza on the occasion. After completion of work, it will become the longest expressway of Uttar Pradesh. It will connect the western and eastern regions of the state. It starts near the Bijauli village in Meerut. It will extend till near the Judapur Dandu village in Prayagraj.
- On the occasion of **Goa Liberation Day**, Prime Minister **Narendra Modi** has inaugurated and laid the foundation stone of several development projects worth over 650 crores rupees in **Goa**. He felicitated freedom fighters and veterans of '**Operation Vijay**' at the function. He appreciated Chief Minister Pramod Sawant for keeping the pace of development up in the state.
- The total number of beneficiaries under the Centre's financial inclusion scheme, **Pradhan Mantri Jan Dhan Yojana (PMJDY)**, has crossed the **44 crore mark**. The total number of accounts opened under PMJDY stood at 44.05 crores, with a total balance of ₹1,47,812 crore as on **December 8**. **Uttar Pradesh** tops the list with the highest number of accounts followed by **Bihar**. Since its launch in 2014, the scheme has been steadily expanding its base.
- **Niti Aayog's Atal Innovation Mission** has unveiled **Vernacular Innovation Programme**, which will enable innovators and entrepreneurs in India to have access to the innovation ecosystem in 22 scheduled languages by the Centre. This will help in overcoming the barriers of language & empower innovators. To get the program rolling, AIM NITI Aayog is launching a train-the-trainer program where it will collaborate with the Design Department of IIT Delhi to coach the VTF in design thinking and entrepreneurship and the adaptation of these subjects in the 22 languages and cultures.
- **Docprime tech** has launched India's first health locker integrated with **Ayushman Bharat Digital Mission (ABDM)**. ABDM was launched in August 2020 for developing an integrated digital health infrastructure in the country. ABDM integrated Health Locker will provide users a digital and self-consented health data management system without any charges. It will store and manage health records electronically.
- Prime Minister **Narendra Modi** has inaugurated and laid the foundation of the hydropower projects worth **Rs 11000 crore in Mandi, Himachal Pradesh**. He inaugurated the **Sawra-Kuddu Hydro Power Project**, a 111 MW Project which has been built at a cost of around Rs 2,080 crore.
- Prime Minister **Narendra Modi** has inaugurated the 356 Km long **Bina Refinery (Madhya Pradesh)-POL Terminal at Panki (Kanpur, UP) Multiproduct pipeline project** ( capacity of 45 million metric tonnes per annum) with an outlay of Rs 1524 crore (Rs. 1227 crores in UP and Rs. 297 crores in MP).





## States Current Affairs

- Nagaland DGP **T. John Longkumer** officially launched the '**Call your Cop**' mobile App at Police Headquarters in **Kohima**. The App was developed by **Excellogics Tech Solutions Pvt Ltd**. The App will enable all citizens of the state especially those in distress to get in touch directly with the police as easily available with just one click away.
- **Varanasi**, a city in **Uttar Pradesh** is all set to become the first Indian city to start ropeway service as a mode of public transport in order to ease the traffic congestion. The proposed ropeway will be constructed between **Cannt Railway Station (Varanasi Junction)** to **Church Square (Godauliya)** covering an aerial distance of **3.45 km**.
- **Kerala Tourism** launched the '**STREET**' project to promote and take tourism deep into the interiors and rural hinterland of Kerala. The project would help visitors experience the diversity of offerings in these locales. The STREET is an acronym for **Sustainable, Tangible, Responsible, Experiential, Ethnic, Tourism hubs**.
- **Nagaland** is celebrating its **59th Statehood Day** on **1 December 2021**. Nagaland was granted statehood on December 1, 1963, with Kohima being declared as its capital. Prior to this, Naga leaders and the central government reached an agreement to create a separate region of the Naga Hills in 1957. The State of Nagaland Act, 1962, was thus enacted by the Parliament to give Nagaland statehood.
- The **Arunachal Pradesh (AP) Government** has signed Bollywood actor **Sanjay Dutt** as the brand ambassador and award-winning filmmaker and branding expert **Rahul Mittra** as brand advisor of the occasion of their golden jubilee celebrations, marking the **50th year** of the naming of the state. Sanjay Dutt launched a media campaign for the month-long celebrations, from 20th January to **20th February 2022 at the Mechuka valley of AP's Shi-Yomi district**.
- The biggest cultural extravaganza of **Nagaland**, the **Hornbill Festival** has kicked off with colorful renditions of traditional music, dances, and contemporary in one roof at **Naga Heritage village Kisama**. It is the **22nd edition** of the Hornbill festival and will be celebrated in 6 districts of Nagaland. This year's edition of Nagaland's iconic Hornbill Festival, widely hailed as the "**festival of festivals**".
- **Himachal Pradesh Police** has conducted the '**President's Colour Award**' ceremony at Shimla's historic Ridge Ground. The Governor bestowed the '**President's Color Award**' to the State Police on this occasion. Director-General of Police **Sanjay Kundu** received the award on the behalf of state police.
- Jharkhand Chief Minister, **Hemant Soren** has launched a web portal named '**Hamar Apan Budget**' and a mobile application prepared by the state finance Department from the Chief Minister's residential office in **Ranchi**. Through this portal, the general public of the state can share their suggestions for the **2022-23 budget**.
- **Gujarat** has left behind **Maharashtra** to become the country's leading manufacturing hub, according to data from the **Reserve Bank of India (RBI)**. Gujarat saw its Gross Value Addition (GVA) in manufacturing grow by **15.9 per cent** annually between FY12 to FY20 to stand at Rs 5.11 lakh crore, data shows. GVA is an economic metric that measures the supply of goods and services in an economy.
- The **Kazhuveli wetland** situated in **Villupuram district** of **Tamil Nadu** has been declared as the **16th Bird Sanctuary** by Surpiya Sahu, Environment and Forest Secretary, at the Minister of Environment Forest and Climate Change. The declaration was made under subsection (1) of section 18 of the Wildlife (Protection) Act, 1972. The Kazhuveli wetlands is referred to as the 2nd largest **Brackish Water Lake** in South India, only after Pulicat lake.
- **Uttar Pradesh Cabinet** has approved the **Atma Nirbhar Krishak development scheme** for boosting the agriculture sector. Atma Nirbhar Krishak development scheme will be implemented from the current financial year. Under this scheme, **1,475 Farmer Producer Organisations (FPOs)** will be formed in the next three years in each development block.
- Chief Minister of Uttarakhand, **Pushkar Singh Dhami** has launched the '**Milk Price Incentive Scheme**' in Dehradun. The scheme is aimed to provide incentives benefiting around 53,000 people of Uttarakhand. The state government is targeting to spend **INR 444.62 crore** to open 500 milk sales centres in Uttarakhand. It is a **Direct Bank Transfer (DBT) scheme**, the amount under the scheme would go directly into the accounts of the beneficiaries through their linked bank accounts.

- The **Haiderpur Wetland** abutting the **Madhya Ganga barrage**, about 10 km from **Bijnor** in western **Uttar Pradesh**, has been recognised under the **1971 Ramsar Convention on Wetlands**. Uttar Pradesh is now home to **9 Ramsar wetlands**. The wetland has also been identified under **Namami Gange**, a central flagship, as a model wetland along the Ganga. With this, there are now a total of 47 such designated areas in the country.
- **Himachal Pradesh govt** announced setting up a Commission for upper castes, on the lines of Madhya Pradesh. The Commission, to be named as '**Samanya Varg Aayog**', will be formalised through a legislative enactment in three months' time when the state assembly meets next in February-March 2021 for the budget session of the House.
- In **Madhya Pradesh**, the first drone fair in the country was organised at **Gwalior**. **Gwalior Drone Mela** was organised jointly by the Ministry of Civil Aviation, the Government of India, the Government of Madhya Pradesh, and the **Federation of Indian Chambers of Commerce & Industry (FICCI)**.
- **Ministry of Environment, Forest and Climate Change (MoEF&CC)**, an area of **454.65 square kilometres** around the boundary of **Askot Wildlife Sanctuary** in the **Pithoragarh** district of Uttarakhand has been declared as the **Askot Wildlife Sanctuary Eco-sensitive Zone (ESZ)**. The notified area extends from **0 to 22 km** around the Askot Wildlife Sanctuary.
- The **Asian Development Bank (ADB)** has approved a **\$112 million loan** to strengthen skills education and training through the establishment of the **Assam Skill University (ASU)**. The Loan will create a path for skill development to enhance the productivity and competitiveness of Assam's economy and industries.
- The Chief Minister of Jharkhand, **Hemant Soren** has launched a **Sports Action toward Harnessing Aspiration of Youth (SAHAY)** scheme aimed at nurturing young sporting talents in Maoist-hit districts of the state. This scheme has been launched to curb the Left Wing Extremism (LWE) which affected 19 of the state's 24 districts. Boys and girls in the 14-19 age group from villages to ward level will be registered under the scheme and will be given opportunities to display their skills in basketball, volleyball, hockey and athletics.
- **Goa Liberation Day** is observed on **19 December** every year in India and it marks the day Indian armed forces freed Goa in **1961** following **450 years of Portuguese rule**. The year 2021 marks the **60 years of Goa's independence**. Goa Liberation Day is marked by an abundance of events and festivities in Goa though this time because of the pandemic the celebrations are expected to be muted.
- Haryana's Minister of State for Sports and Youth Affairs, **Sandeep Singh** launched '**Khel Nursery Scheme 2022-23**' to promote sports in the state. The players of Haryana have given a new identity to the state at the international level with their sports talent. The state government is always striving to develop new sports talents in the state.
- **Tamil Nadu government** has announced '**Tamil Thaa Vaazhthu**' as the state anthem. It should be sung before the start of any functions in all educational institutions, universities, government offices, and public sector undertakings. The decision comes in the wake of the Madras High Court recently ruling that '**Tamil Thai Vaazhthu**' is a prayer song and not an anthem.
- Uttarakhand Chief Minister **Pushkar Singh Dhami** has announced that Indian wicket-keeper batsman **Rishabh Pant** has been appointed as the brand ambassador of the state. The 24-year Pant, who was rested for the New Zealand Tests, is currently in South Africa as the Indian Team is all set to face Proteas in the three-match Test series, starting December 26.

- The **Yogi Adityanath government** in **Uttar Pradesh** is set to launch the ambitious '**Free Smartphone Yojana**' on December 25, which is the birth anniversary of senior BJP leader and former Prime Minister Atal Bihari Vajpayee. Under the scheme, the state government will distribute smartphones and tablets to final year students of graduation and above.
- Chief Minister of Odisha, **Naveen Patnaik** has inaugurated the state's longest bridge, '**T-Setu**', built over the **Mahanadi River** in Cuttack District, Odisha. The bridge in the shape of the English alphabet 'T' was constructed at a cost of **Rs 111 crore**. The 4-km-long bridge connecting Gopinathpur in Badamba, Baideswar in Banki to Singhanath Pitha in Cuttack, will cut the distance between Badamba and Banki Baideswar by almost 45 km.

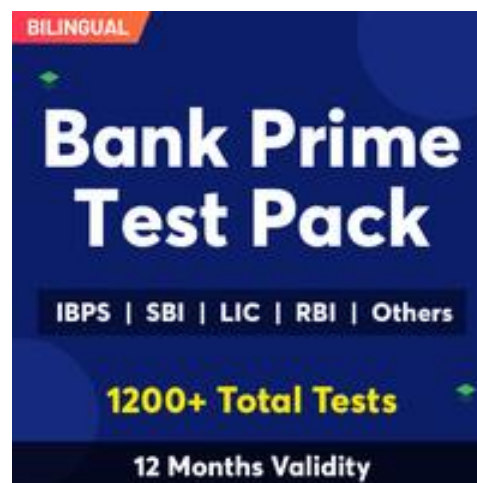

- According to **Lowy Institute Asia Power Index 2021**, **India** has ranked **4th** most powerful country in the **Asia-Pacific region** for comprehensive power out of 26 countries, with an overall score of **37.7 out of 100**. India's overall score declined by 2 points compared to 2020. India again falls short of the major power threshold in 2021. India is one of 18 countries in Asia to trend downward in its overall score in 2021.

- The **9th edition of India Skills Report (ISR) 2022**, released by Wheebox, **Maharashtra** has retained the top position in the list of states with the highest poll of employable talent followed by Uttar Pradesh and Kerala. The theme of ISR 2022 - '**Rebuilding and Reengineering the Future of Work**'.
- **International Institute for Management Development (IMD)** World Competitive Centre published its "**World Talent Ranking Report**". In the report, Europe has dominated the ranking in 2021. Global top 10 countries are from this region. **Switzerland** has retained its top spot. India has been ranked at **56th position**. In the Middle East & North Africa, **UAE maintained its second position**, following Israel (first in this region). Israel has been ranked 22nd.
- Winter Session of the Parliament, **Nitin Gadkari**, Union Minister of Road Transport & Highways, informed the Rajya Sabha on the state of **Electric Vehicles (EV) in India**. As per the data, India has a total of 870,141 registered EVs, with Uttar Pradesh (UP) holding the top spot with 255,700 registered EVs. UP is followed by **Delhi** (125,347), **Karnataka** (72,544), **Bihar** (58,014) and **Maharashtra** (52,506) in successive positions.
- As per the **Global Health Security (GHS) Index 2021**, the world's average overall GHS Index score was reduced to 38.9 (out of 100) in 2021, from a score of 40.2 in the GHS Index, 2019. **India** ranked **66 out of 195 countries** with an overall Index score of 42.8 and along with a change of -0.8 from 2019. The **United States of America (USA)** ranked **1st** on the index with a score of 75.9 followed by **Australia and Finland**.
- **Maharashtra** has topped the list of states with the maximum number of beneficiaries under the **Atmanirbhar Bharat Rojgar Yojana (ABRY)**, followed by **Tamil Nadu** and **Gujarat**. As many as 6,49,560 beneficiaries were recorded in Maharashtra, followed by Tamil Nadu (5,35,615), Gujarat (4,44,741) and Karnataka (3,07,164). In Maharashtra, the beneficiaries have been provided with a total of Rs 409.72 crore under the scheme to new employees of 17,524 establishments.
- Spam call rates in **India** have spiked again, with the country moving up in global rankings from 9th position to **4th position** owing to a significant in sales and telemarketing calls in 2021, according to the latest insights by callerID, spam detection and blocking company, **Truecaller**. The top three countries in the world with maximum spam based calls were **Brazil, Peru and Ukraine**. Interestingly, the USA dropped from 2nd place in 2020 to 20th in 2021, owing to stringent government regulations.
- **Reliance Industries Ltd**, India's largest corporate by revenues, profits and market value, topped the **2021 Wizikey News Score ranking** as India's most-visible corporate in the media. On the global rankings chart for top Multinational Corporations(MNC), Facebook tops the index, followed by Google's Alphabet Inc. Notably, Reliance is ranked eighth on global rankings for top MNCs.
- **India** is among the world's **top three dope violators** country in the world. Indian athletes were involved **152 times** in dope-related activities in the year 2019. The report has revealed the latest report published by the **World Anti-Doping Agency (Wada)**, which has put India into the top-three of the world's biggest violators behind **Russia (167) and Italy (157)**. **Brazil (78)** is at fourth and **Iran (70)** fifth positions.
- Adding **33 "unicorns"** in a single year has helped **India** displace the **United Kingdom** to be third in the list of countries that are home to such enterprises valued at over **\$1 billion each**. The **US and China**, who occupy the first two ranks, are way ahead, according to the data compiled by Hurun Research Institute.
- **Telangana** has secured 1st place among the 34 states and Union Territories that implement the **Shyama Prasad Mukherji Rurban Mission (SPMRM)**. **Tamil Nadu and Gujarat** have secured 2nd and 3rd place on the list respectively. In the Ranking of the Cluster, among the 295 clusters, the **Ryakal cluster of Sangareddy and the Jukkal cluster of Kamareddy** in Telangana has secured the 1st and 2nd position respectively. The **Aibawk cluster of Aizawl** in Mizoram has secured the 3rd position.





## Sports Current Affairs

- New Zealand's **Ajaz Patel** became the third cricketer to scalp all **10 wickets** in an innings. The left-arm spun a web around India's batting order and bowled **47.5 overs, conceding 119 runs**. New Zealand bundled out India for 325 on the second day of the second Test at the Wankhede Stadium, Mumbai.
- Mercedes driver **Lewis Hamilton (Britain)** won the inaugural edition of the **Saudi Arabian Grand Prix (GP)**, by surpassing **Max Verstappen (Netherlands)** in the event held at the 30-kilometre (18.6-mile) coastal resort area in Jeddah, Saudi Arabia. **Reema Juffali**, has been appointed as an ambassador for the first edition of the Saudi Grand Prix, under the Formula 1 (F1) World Championship.
- The **Davis Cup 2021** was won by the **Russian Tennis Federation** by a 2-0 lead over Croatia in the **Davis Cup final in Madrid**. Medvedev defeated Marin Cilic in the second singles match to give Russia an insurmountable 2-0 lead over Croatia and its first Davis Cup title since 2006. Croatia also was seeking its third title after triumphs in 2005 and 2018. **Andrey Rublev** was named the Most Valuable Player.
- Sanket Mahadev Sargar** won the gold medal in **Men's 55 kg snatch category** at the ongoing **Commonwealth Weightlifting Championships 2021**. He created the national record by lifting 113kg in the men's 55kg snatch category. Sargar has also qualified for the upcoming 2022 Commonwealth Games in Birmingham.
- Manipur** successfully defended their **Senior Women's National Football Championship** crown after a dramatic penalty shootout win over **Railways in the final** at the EMS Stadium in **Kozhikode, Kerala**. After a dearth of goal-scoring chances in regulation and extra time, the match went to penalties with the scores at 0-0. Manipur goalkeeper Okram Roshini Devi produced three saves to give her side their 21st title at this level.
- India** claimed 41 medals (12 Gold, 15 Silver, 14 Bronze) at the **4th Asian Youth Para Games (AYPG)**, Asia's biggest event held at **Riffa city, Bahrain**. The event is organized by the **National Paralympic Committee (NPC)** of Bahrain with the support of the local government. Over 700 athletes from around 30 countries participated in the event from 2nd to 6th December 2021. The 5th edition of the Asian Youth Para Games 2025 will be hosted by Tashkent, Uzbekistan.
- Denmark's Viktor Axelsen** and China's Taipei's **Tai Tzu Ying** were named Male and Female **player of the year 2021** respectively by the **Badminton World Federation (BWF)**.
- India** claimed 41 medals (12 Gold, 15 Silver, 14 Bronze) at the **4th Asian Youth Para Games (AYPG)**, Asia's biggest event held at **Riffa city, Bahrain**. The event is organized by the **National Paralympic Committee (NPC)** of Bahrain with the support of the local government. Over 700 athletes from around 30 countries participated in the event from 2nd to 6th December 2021. The 5th edition of the Asian Youth Para Games 2025 will be hosted by Tashkent, Uzbekistan.
- Reigning world chess champion **Magnus Carlsen** of Norway defended his title and won the **FIDE World Championship in Dubai**.
- Red Bull's **Max Verstappen** won his maiden **F1 Drivers' championship** title by beating Lewis Hamilton of Mercedes in the season-ending **Abu Dhabi GP 2021**.
- India** won a total of six medals, including two gold and 4 silver medals in the **Asian Rowing Championship in Thailand**. Senior rower **Arvind Singh** bagged a gold in the lightweight Men's single sculls event while his compatriots won three silver medals.
- The **International Boxing Association** has changed its acronym from **AIBA to IBA**, promising to adopt a set of governance reforms so as to keep the sport's inclusion at the **2028 Olympics**.
- A total of **148 athletes, including 20 new inductees**, in seven Olympic disciplines and six Paralympic disciplines, have been identified for support under the **Target Olympic Podium Scheme** at a meeting of the **Mission Olympic Cell** of the Ministry of Youth Affairs and Sports. The TOP scheme which is an attempt to provide assistance to India's top athletes. This scheme was started in **2014**.
- Sports Minister **Anurag Singh Thakur** formally inaugurated the first-ever national-level **Khelo India Women's Hockey League** at **Major Dhyan Chand National Stadium in New Delhi**. The winner of the **Khelo India Women's Hockey League** will get a cash prize of **30 lakhs**. In the first phase, total 14 teams will participate in the league and 42 matches will be played from 15 December to 21 December.
- India** concluded the **Commonwealth Weightlifting Championships 2021** with 16 medals - 4 Gold, 7 Silver, and 5 Bronze, held at **Tashkent, Uzbekistan**. Bindyarani Devi was India's only medallist at the World Weightlifting Championships 2021, that was also held parallelly at Tashkent.

- Former world champion **PV Sindhu** has been appointed as a member of the Badminton **World Federation's (BWF) Athletes' Commission**, along with five other people. The Chair and Deputy Chair will be decided among the six members. The Chair of the BWF Athletes' Commission, following a vetting process as required for all Council members, will become a member of the Council until the next elections in **2025**. Iris Wang (USA), Robin Tabeling (NED), Greysia Polii (INA), Kim Soyeong (KOR), Pusarla V Sindhu (IND) and Zheng Si Wei (CHN) are the ones appointed as members of the BWF Athletes' Commission.
- Indian teenager **Anahat Singh** has scripted history by winning the U-15 girls category of the prestigious **Junior US Open Squash tournament in Philadelphia**.
- **India** defeated **Pakistan 4-3** to secure the **bronze medal**, while **Korea** defeated **Japan 4-2** to emerge **Asian Champions Trophy men's hockey tournament** held in Dhaka, Bangladesh. The five-nation tournament came to an end with two matches being played on the last day of the game. **Kanta Tanaka** of Japan was declared the best player of the tournament while **Suraj Karkera** of India was adjudged the best goalkeeper. **Jang Jonghyun** of Korea was the top scorer with 10 goals in the tournament.
- **Bangladesh** women team has won the **SAFF U 19 Women's Championship** by defeating India in the finals. **Shaheda Akter Ripa** of Bangladesh scored the maximum number of goals in the tournament. She received the '**most valuable player**' award. The 2021 SAFF U-19 Women's Championship was the 2nd edition of the SAFF U-19 Women's Championship.
- Indian skier **Aanchal Thakur** has bagged a bronze medal at the **International Ski Federation (FIS) Alpine Skiing Competition in Montenegro**. She finished 3rd with an overall timing of 1:54:30. **Croatia's Dora Ljutic** (1:50.61) won the gold medal while Cyprus skier **Georgia Epiphaniou** (1:52.71) clinched silver.
- Senior Indian off-spinner, **Harbhajan Singh** has announced retirement from all forms of **cricket**. He was the 1st Indian Cricketer to take Hat-trick wickets in Test Cricket. He took 417 wickets in 103 Tests and is the 4th highest wicket-taker for India in Test cricket.
- **Pankaj Advani** has defended his **National Billiards Title** by winning his 11th tournament, after defeating his PSPB teammate **Dhruv Sitwala** in a 5-2 game final that was held in **Bhopal, Madhya Pradesh**.
- **Himachal Pradesh** beat **Tamil Nadu** by 11 runs (VJD Method) in the final to win their maiden **Vijay Hazare Trophy title**, at the Sawai Mansingh Stadium, Jaipur.
- **Uttar Pradesh** has crowned the winners of the **11th Junior National Men's Hockey Championship** following a 3-1 victory over **Chandigarh** in the final at Kovilpatti, Tamil Nadu. Tournament top scorer **Sharda Nand Tiwari** opened the scoring for Uttar Pradesh.
- **Nitesh Kumar** won doubled gold at the **4th Para-Badminton National Championship**, which concluded in **Bhubaneswar, Odisha**. Haryana's Nitesh along with his partner **Tarun Dhillon** defeated World No. 1 Paralympic Games gold medallist **Pramod Bhagat and Manoj Sarkar** in straight sets 21-19, 21-11 in the Men's doubles finals to win the gold.
- **World Anti-Doping Agency (WADA)** has restored the accreditation of the **National Dope Testing Laboratory (NDTL)** in accordance with the **International Standard for Laboratories (ISL)**, which had been suspended since **August 2019**. With this, NDTL's Anti-Doping testing and activities will be resumed with immediate effect.
- **Mohammed Shami** became just the **11th Indian bowler** to claim **200 wickets** in Test cricket in just 55 test matches. During this process, he became the only 5th Indian pacer to bag 200 wickets in the purest format of the game. Also, Shami is the third fastest Indian pacer to reach this milestone as Kapil Dev and Javagal Srinath bagged 200 Test wickets in 50 and 54 Tests respectively.
- **Jasprit Bumrah** has achieved the milestone of picking **100 wickets** away from home in **22 Test matches**. Van der Dussen became Bumrah's 100th Test victim in overseas conditions. The 28-year-old now has 105 wickets, out of which 101 have come away from home. Bumrah, who made his Test debut in South Africa in 2018, has played 25 Tests, 23 of which have come on the road.

## Summits And Conferences

- **India** has joined '**G20 Troika**' and will work closely with Indonesia and Italy to ensure consistency and continuity of **G20's agenda**. Apart from India, Troika consists of Indonesia and Italy. India will assume G20 Presidency in December 2022 from **Indonesia** and will convene the **G20 Leaders' Summit** for the first time in **2023**. Troika refers to the top grouping within G20 that consists of the current, previous, and incoming presidencies (Indonesia, Italy and India).
- Prime Minister **Narendra Modi** virtually inaugurated a thought leadership forum on FinTech, '**InFinity Forum**'. The event was hosted by International Financial Services Centres Authority (IFSCA), under the aegis of the Government of India in collaboration with GIFT City and Bloomberg. **Indonesia, South Africa and the United Kingdom** were the partner countries in the 1st edition of the Forum. The Forum focused on the theme of '**Beyond**' with various sub-themes.
- Union Minister of External Affairs (EAM) **Subrahmanyam Jaishankar** has visited **Abu Dhabi, United Arab Emirates (UAE)** to attend the **5th Indian Ocean Conference** on December 4-5, 2021. The theme of the conference was '**Indian Ocean: Ecology, Economy, Epidemic**'. The Conference is chaired by Sri Lankan President, **Gotabaya Rajapaksa** & Vice Chairs are S.Jaishankar, Vivian Balakrishnan, Sayyid Badr Bin Hamad Bin Hamoud Al Busaidi.
- Prime Minister **Narendra Modi** and Russian President **Vladimir Putin** held the 21st India-Russia Annual Summit to discuss the entire gamut of relations, including regional and global issues. During his visit, India and Russia signed **28 agreements**. The leaders discussed on International North-South Transport Corridor and also about the Chennai - Vladivostok Eastern Maritime Corridor (which is under the proposal).
- US President **Joe Biden** is hosting the first of two **Summits for Democracy**, which takes place virtually between **December 9-10**. India's Prime Minister Narendra Modi virtually addressed the summit saying that '**democratic spirit**' and '**pluralistic ethos**' are ingrained in Indians. A total of 100 nations participated in this 'Summit for Democracy'. PM Modi highlighted India's civilisational ethos as one of the original sources of democracy. He outlined sensitivity, accountability, participation, and reform orientation as four pillars of Indian democratic governance, stressing that principles of democracy should also guide global governance.

- The Department for Promotion of Industry and Internal Trade (DPIIT) has launched the **Unified Logistics Interface Platform's (ULIP) hackathon - 'LogiXtics'** to crowdsource more ideas that will benefit the logistics industry. The Unified Logistics Interface Platform (ULIP) Hackathon - LogiXtics is being organised by **NITI Aayog and Atal Innovation Mission**.
- The third Annual **Defence Dialogue** between **India and France** took place between Defence Minister **Rajnath Singh** and his French counterpart Florence Parly in New Delhi. A wide range of bilateral, regional, defence and defence industrial cooperation issues were discussed in the annual meeting.
- **India** will chair the **Counter-Terrorism Committee of UNSC** in **January 2022** after **10 years**. The Counter-Terrorism Committee was established by **Security Council resolution 1373** adopted unanimously on 28 September 2001 in the wake of the 9/11 terror attacks in the US.

## Awards & Recognition

- **Lionel Messi** has won the **Ballon d'Or** for a seventh time after being named as the **best player** in **2021** by **France Football**. Messi scored 41 goals and registered 17 assists in 56 appearances in all competitions for club and country and led Argentina to a long-awaited Copa America win in the summer.
- Vice-Chancellor (VC) of Professor Jayashankar Telangana State Agricultural University, **V Praveen Rao** wins the **7th Dr M S Swaminathan Award** for the period **2017-19**. It is a biennial national (every 2 years) award that was presented by the retired ICAR (Indian Council of Agricultural Research) Employees Association (RICAREA) and Nuziveedu Seeds Limited. It carries a cash prize of **INR 2 lakh** and a citation.
- A biography titled '**Naoroji: Pioneer of Indian Nationalism**', authored by **Dinyar Patel** and published by Harvard University Press selected as the winner of the **4th Kamaladevi Chattopadhyay NIF (New India Foundation) Book Prize 2021**. The book marked the life events and legacy of **Dada Bhai Naoroji**. It also contains the historical background of India's National Movement during the 19th century.



- Union Commerce and Industry Minister, **Piyush Goyal** has inaugurated the **40th edition** of the **India International Trade Fair (IITF) 2021** at **Pragati Maidan in Delhi**. It was organized by the India Trade Promotion Organisation with 'Aatmanirbhar Bharat' as the theme and to further promote the idea of '**Vocal for Local**'. Bihar is the partner state for the 40th IITF and the focus states are **Uttar Pradesh and Jharkhand**. The Bihar pavilion won the 6th gold medal by showcasing the state's art and cultural richness through handicrafts like **Madhubani, Manjusha arts, terracotta, handlooms**, and other indigenous products of the state at IITF 2021.
- On the occasion of **Assam Divas**, the state government of Assam has decided to accolade renowned industrialist **Ratan Tata** with the '**Asom Bhaibav**' award, the highest civilian state award for his contribution to cancer care in the state. The awards that precede it are Asom Saurav, followed by Asom Gaurav. With healthcare as one of its top priorities, the Assam government is showing its appreciation towards Tata's push to cancer care in the region.
- **Nizamuddin Revival Project**, India's project on the holistic urban revitalisation of the historic **Nizamuddin Basti community, in New Delhi** has won the UNESCO Asia-Pacific Awards for Cultural Heritage Conservation 2021. The project involves the meticulous restoration of over 20 historic monuments clustered around the 14th-century mausoleum of the revered Sufi saint, Hazrat Nizamuddin Auliya.
- Indian-American mathematician, **Nikhil Srivastava**, who teaches at the University of California, Berkeley along with **Adam Marcus** and **Daniel Spielman** were awarded the First **Ciprian Foias Prize** in Operator Theory by the **American Mathematical Society (AMS)**. Adam Marcus holds the Chair of Combinatorial Analysis at the Ecole Polytechnique Federale de Lausanne (EPFL) in Switzerland. Daniel Spielman is a Sterling Professor of Computer Science, a professor of statistics and data science, and a professor of mathematics.
- Assamese poet **Nilmani Phookan Jr** won the **56th Jnanpith Award** and Konkani novelist **Damodar Mauzo** won the **57th Jnanpith Award**. The country's highest literary award, the Jnanpith is bestowed on writers for "their outstanding contribution to literature". Jnanpith Award is a literary award presented by the Bharatiya Jnanpith organization to Indian writers every year. This was instituted in 1961 and is given only to Indian writers who write in Indian languages and English.
- **Ropesh Goyal** from IIT-Kanpur won the '**Young Geospatial Scientist**' award in recognition of his unique contribution to developing the **Indian Geoid Model** and computation software. Member of Space Commission, Government of India, and former ISRO Chairman **AS Kiran Kumar** presented the award to Goyal during the inaugural event of the DigiSmart India 2021 conference hosted by the Geospatial World.
- The **Royal Institute of British Architects (RIBA)** has announced that Indian architect **Balkrishna Doshi** will be the recipient of the **2022 Royal Gold Medal**. The distinction, approved by Her Majesty The Queen and awarded each year since 1848, is given to architects or practices in recognition of a lifetime's work and the impact on the evolution of the field and the built environment.
- Indian Mathematician **Neena Gupta** has received the **2021 DST-ICTP-IMU Ramanujan Prize for Young Mathematicians from Developing Countries** for her outstanding work in affine algebraic geometry and commutative algebra.

- The **All India Co-ordinated Research Project (AICRP)** on poultry breeding, Mannuthy, under the **Kerala Veterinary and Animal Science University (KVASU)**, bagged the national breed conservation award for 2021.



## Important Days

- **World AIDS Day** is observed across the globe on **1st December** every year since **1988**. The day provides an opportunity for people worldwide to unite in the fight against HIV, to show support for people living with HIV and to commemorate those who have died from an AIDS-related illness. This year the theme of World AIDS Day is **End inequalities. End AIDS and End Pandemics**.
- **National Pollution Control Day** is observed on **2nd December** every year. The day is observed as a national pollution control day to commemorate the lives of the people who died in the **Bhopal gas tragedy in 1984**.
- **World Computer Literacy Day** is observed on **2nd December** every year all over the world. The day is celebrated as the world computer literacy day to create awareness and drive digital literacy in underserved communities worldwide.
- **International Day for the Abolition of Slavery** is observed annually on **2nd December** since **1986** by the United Nations General Assembly. The focus of this day is on eradicating contemporary forms of slavery, such as trafficking in persons, sexual exploitation, the worst forms of child labour, forced marriage, and the forced recruitment of children for use in armed conflict.
- **World Handicapped day** also known as the **International Day of Persons with disabilities** is observed every year on **3rd December** globally. The day is marked and observed to support critical issues which are related to the inclusion of persons with disabilities. The IDPWD day was proclaimed in **1992** by the United Nations General Assembly. The theme of the World Day of the Handicapped 2021 is the **Leadership and participation of persons with disabilities**.
- In India, **December 4** is observed as the **National Navy Day** every year, to celebrate the achievements and role of the naval force to the country. The theme of Indian Navy Day 2021 is '**Swarnim Vijay Varsh**' signifying 50 years of India's victory in the Indo-Pakistan war that took place in 1971.
- **World Soil Day** is celebrated every year on **December 5** to raise awareness of the importance of soil quality for human well-being, food security and ecosystems. World Soil Day 2021 (#WorldSoilDay) and its campaign "**Halt soil salinization, boost soil productivity**".
- **International Volunteer Day (IVD)**, also called **International Volunteer Day for Economic and Social Development** is observed on **5 December** every year. International Volunteer Day Theme 2021: "**Volunteer now for our common future**".
- **International Civil Aviation Day** is celebrated every year on **December 7** to recognize the importance of aviation to the social and economic development of the world. The Council has decided that from now until 2023, the theme will be: "**Advancing Innovation for Global Aviation Development**".
- **National armed forces day** is also known as the **National flag day of India**. The day is every year celebrated and observed on **7th December**.
- The **International Day of Commemoration and Dignity of the Victims of the Crime of Genocide and of the Prevention of this Crime** is observed annually on **December 9**.
- **International Anti-Corruption Day** is observed annually on **9 December** to raise public awareness for anti-corruption. The day is observed since the passage of the United Nations Convention Against Corruption on **31 October 2003**. The theme of International Anti-Corruption Day 2021: "**Your right, your role: say no to corruption**".
- The **South Asian Association for Regional Cooperation (SAARC) Charter Day** is observed annually on **8th December** to commemorate the adoption of the **SAARC Charter**. This year marks the **37th** anniversary of the regional group. The charter was signed by the Leaders of SAARC Countries Heads of State or Government of **Bangladesh, Bhutan, India, Maldives, Nepal, Pakistan and Sri Lanka** at the First SAARC Summit held in **Dhaka, Bangladesh**.
- **Human Rights Day** is celebrated on **10 December** annually across the world. This Day came into existence on December 10, 1948, when the Universal Declaration of Human Rights was adopted by the United Nations. The theme for Human Rights Day 2021 is "**EQUALITY - Reducing inequalities, advancing human rights**."
- **International Mountain Day** is observed globally on **December 11** every year. The theme of this year's International Mountain Day (IMD) on 11 December will be **sustainable mountain tourism**.
- **International Universal Health Coverage Day** is a United Nations' recognized international day celebrated every year on **December 12**. This year theme of International Universal Health Coverage Day is "**Leave No One's Health Behind: Invest in health systems for all**."



- **International Day of Neutrality** is a United Nations recognized day held on **December 12** each year to raise public awareness of the value of neutrality in international relations. It was officially declared by a UN General Assembly resolution adopted in February 2017 and first observed on December 12, 2017.
- Every year, **UNICEF Day** is observed on **December 11** to raise awareness about saving children's lives by defending and helping them to fulfil their wishes. The theme for this year is **to help children recover from interruptions and learning losses experienced through pandemics in the last two years**.
- Every year on the **14th of December**, **National Energy Conservation day** is celebrated in India. This occasion has been celebrated since **1991** when is led by the **Ministry of power**. This day is celebrated to raise awareness regarding the conservation of energy as it is the best way to have a greener and brighter future.
- In India, **Vijay Diwas (also called Victory Day)** is celebrated every year on **December 16**. The country is celebrating the **50th** Vijay Diwas in **2021**. The Indo-Pakistan war of **1971** which began on **December 3** lasted for 13 days and officially ended on December 16, after which Pakistan surrendered to India.
- **International Tea Day** is observed every year on **December 15** in countries like **Bangladesh, Sri Lanka, Nepal, Vietnam, Indonesia, Kenya, Malawi, Malaysia, Uganda, India, and Tanzania**.
- The **International Migrants Day** is observed globally on **18 December** every year. The day is marked by the United Nations, through the UN-related agency **International Organization for Migration (IOM)**. The theme of International Migrants Day 2021 is **Harnessing the potential of human mobility**.
- Every year, **December 18** is observed as the **Minorities Rights Day** to uphold the right to freedom and equal opportunities for the ethnic minorities in India and create awareness about the respect and dignity of the minorities.
- **World Arabic Language Day** is observed globally on **18th December** every year. The Arabic language is one of the pillars of the cultural diversity of mankind. The theme of this year's World Arabic Language Day is **"The Arabic Language and Civilizational Communication"**.
- **International Human Solidarity Day** is observed globally on **20 December** every year to celebrate unity in diversity and raise awareness about the importance of solidarity. According to the United Nations Millennium Declaration, solidarity is among the fundamental values that are essential to international relations.
- Union Minister **Dr. Jitendra Singh** has inaugurated the **Good Governance Week** campaign themed **"Prashasan Gaon Ki Aur"** aimed at showcasing and replicating the best governance practices to the grassroots level. Good Governance Week is being celebrated on **20-25 December** as part of the Azadi Ka Amrit Mahotsav celebration.
- **Kisan Diwas or National Farmers' Day** is celebrated across the nation on **December 23** to commemorate the birth anniversary of the fifth Prime Minister of India, **Chaudhary Charan Singh**. He brought farmer-friendly policies and worked towards the welfare of the farmers. He was the fifth Prime Minister of India and served the country as Prime Minister from 28 July 1979 to 14 January 1980.
- **National Consumer Rights Day** is observed every year on **December 24**. On this day in 1986, the Consumer Protection Act 1986 received Presidential assent and thus came into force. The Act aims to provide consumers with effective safeguards against different types of exploitation, such as defective goods, deficiency in services and unfair trade practices.
- India observes the **National Mathematics Day** every year on **22 December** since 2012. The day is celebrated to commemorate the birth anniversary of Mathematician **Srinivasa Ramanujan**. This year nation celebrates his **134th** birth anniversary of Ramanujan. The main objective behind the celebration of National Mathematics Day is to make people aware of the development of mathematics and its importance in the growth of humanity.
- In India, **Good Governance Day (Sushasan Divas)** is observed annually on **25th December**. In this day nation celebrates the birth anniversary of **Bharat Ratna** and former-Prime Minister **Atal Bihari Vajpayee**. Good Governance Day was established in **2014** to honour Prime Minister Vajpayee by fostering awareness among the Indian people of accountability in government.
- The United Nations and World Health Organization marked **December 27** as the **International day for Epidemic Preparedness**. Battered by the Covid-19 pandemic, humans have learned about epidemic preparedness the hard way. In a bid to prepare for future outbreaks and sensitise people about epidemics on all levels.

## Defence Current Affairs

- The **Border Security Force (BSF)** is celebrating its **57th Raising Day** on **01 December 2021**. BSF was formed on **December 1, 1965** as a unified central agency after the Indo-Pak and India-China wars for ensuring the security of the borders of India and for matters connected therewith.
- **Indian shipbuilder Garden Reach Shipbuilders & Engineers (GRSE)** has achieved a new milestone with the launch of the first large survey vessel for the Indian Navy. Called **Sandhayak**, the vessel is the first in the series of four ships being built under the Survey Vessel Large (SVL) project. It has been built at GRSE.
- The **11th edition** of Exercise **EKUPERIN-21** between **India and Maldives**, held at **Kadhdhoo Island, Maldives**. Ekuverin means "Friends" in the Dhivehi language. It is an Indo - Aryan language. It is spoken in India, Lakshadweep and Maldives. The exercise enhances synergy and inter-operability between the Armed Forces of both nations in terms of understanding transnational terrorism both on land and at sea, conducting Counter-Terrorism and Counter-Insurgency Operations and sharing best military practices and experiences.
- **PANEX-21** is a Humanitarian Assistance and Disaster Relief Exercise. It is to be held for the **BIMSTEC countries**. The exercise is to be held among the BIMSTEC countries: **Bhutan, Bangladesh, Nepal, Myanmar, Sri Lanka, India and Thailand**. The main aim of the exercise is to build regional cooperation in responding to natural disasters. It is to be conducted in Pune from **December 20 to December 22**.
- President of India, **Ram Nath Kovind** has presented the '**President's Standard**' to the **22nd Missile Vessel Squadron** of the **Indian Navy**, which is also known as the **Killer Squadron** at the ceremonial parade held at the **Naval Dockyard, Mumbai, Maharashtra**. To mark this occasion, the postal department has released a special day cover and a commemorative stamp. The year 2021 also marks the 50 years of inception of the Missile Vessel Squadron, also known as Killers.
- **India** successfully test-fired the air version of the **BrahMos supersonic cruise missile** from the integrated test range of **Chandipur**, off the coast of **Odisha**. The air version of the missile was test-fired from supersonic fighter aircraft **Sukhoi 30 MK-I**. BrahMos is a joint venture between **DRDO (India)** and **NPO Mashinostroyeniya (Russia)** for the development, production, and marketing of the supersonic cruise missile which has been inducted into the Indian Armed Forces. The missile derives its name from the rivers of Brahmaputra in India and Moskva in Russia.
- **India** has signed a contract with **Indo-Russia Rifles Pvt. Ltd.**, a Joint Venture between India and Russia for the indigenous production of over **6 Lakh AK-203 Assault Rifles at Korwa, UP**.
- **Defence Research and Development Organisation (DRDO)** has successfully test-fired **Pinaka Extended Range (Pinaka-ER)**, **Area Denial Munitions (ADM)**, and indigenously developed fuzes. The test was conducted at Integrated Test Range (ITR), Chandipur off the Odisha coast. A total of 25 enhanced Pinaka rockets were reportedly fired from multi-barrel rocket launchers (MRLs) at several ranges during the test.
- Defence Minister **Rajnath Singh** has inaugurated **Swarnim Vijay Parv** commemorating **50 years of India's victory in the 1971 war**. He inaugurates '**Wall of Fame -1971 Indo-Pak War**' at the inaugural ceremony. Swarnim Vijay Parv is an event commemorating the valour & professionalism of the Armed Forces and their contribution to the liberation of Bangladesh in the Indo-Pak 1971 war, at India Gate Lawns in New Delhi on December 12, 2021.
- **Defence Research and Development Organisation (DRDO)** and **Indian Air Force (IAF)** successfully flight-tested the indigenously designed and developed Helicopter launched (air-launched) **Stand-off Anti-tank (SANT) Missile** from the Pokhran range in Rajasthan. For the first time that this was launched from a Russian origin **Mi-35 helicopter gunship**.
- **India** has successfully test-fired a long-range **Supersonic Missile Assisted Torpedo (SMART)** off the **Balasore coast in Odisha**. The weapon system is being developed by the **Defence Research and Development Organisation (DRDO)** for the Indian Navy. The system has been designed to enhance anti-submarine warfare capability far beyond the conventional range of the torpedo.
- Army Chief General **M.M. Naravane** has assumed the charge as the **chairman of the Chiefs of Staff Committee** that comprises the three service chiefs. The post fell vacant following the death of Chief of Defence Staff General Bipin Rawat in the Indian Air Force helicopter crash on December 8. General Naravane has been given the charge, as he is the senior-most among the three service chiefs.
- **Hindustan Aeronautics Limited (HAL)** has signed a **Rs 2,400 crores** contract with **Bharat Electronics Limited (BEL)** for the development and supply of 20 types of systems for 83 LCA (Light Combat Aircraft) **Tejas Mk1A fighter aircraft programme**. The duration of the contract is 5 years i.e., from 2023 to 2028.

- The nuclear-capable ballistic missile '**Agni Prime**' was successfully tested off the coast of **Odisha** by the **Defence Research and Development Organisation (DRDO)**. Recently, DRDO has successful test-firing of the air version of the BrahMos supersonic cruise missile on December 7 was a "significant milestone" in BrahMos' development.
- On Goa Liberation Day, Indian Navy's indigenous stealth guided-missile destroyer '**Mormugao**' went for her maiden sea trials. This second indigenous stealth destroyer of the **Project 15 B (P15B) class**, is planning to be commissioned in **mid-2022**. Mormugao is being built at Mazagon Dock Shipbuilders Ltd as part of Project 15B destroyers and incorporates several indigenous technologies.
- **India** successfully conducted the maiden flight test of the indigenously-developed, surface-to-surface missile '**Pralay**' off the Odisha coast. The solid-fuel, battlefield missile developed by the **Defence Research Development Organisation** is based on Prithvi Defence Vehicle from the Indian ballistic missile programme. The missile, launched from the **APJ Abdul Kalam Island**.
- **Indian Air Force (IAF)** has deployed the first squadron of the **S-400 air defence missile system** in the western **Punjab sector** which will take care of aerial threats from **Pakistan and China**. The S-400 air defence system was contracted for by India from Russia in a deal worth around **Rs 35,000 crores** and five squadrons would be provided to India for tackling air threats from up to 400 km.
- **Indian Army** has launched a contemporary messaging application named '**ASIGMA (Army Secure IndiGeneous Messaging Application)**'. It is a new generation web-based application developed entirely in-house by a team of officers of the Corps of Signals of the Army. It works as an alternative to **Army Wide Area Network (AWAN)** messaging application which has been in service for the past 15 years.
- **INS Khukri** (Pennant number 49), the first indigenously built Missile Corvette, was decommissioned after **32 years of service** at Visakhapatnam, Andhra Pradesh. The warship was built by the Mazagon Dock Shipbuilders (MSD) and commissioned on 23rd August 1989 and had been part of both the Western and Eastern Fleets.
- **Defence Research and Development Organisation (DRDO)** has successfully conducted a flight test of Indigenously developed **High-speed Expendable Aerial Target (HEAT) 'Abhyas'** from Integrated Test Range at Chandipur off Odisha coast.
- The **Defence Research and Development Organization (DRDO)** selected **Paras Defence and Space Technologies** for handing over the technology of **border surveillance systems** as developed by Instruments Research & Development Establishment and DRDO. This technology has been transferred by a licensing agreement for the transfer of technology (ToT) for border surveillance systems entered between the company, Instruments Research & Development Establishment (IRDE) and Defence Research and Development Organization (DRDO).
- The **Indian Army** has established the **Quantum Lab at the Military College of Telecommunication Engineering (MCTE)**, in Military Headquarters Of War (Mhow), **Indore, Madhya Pradesh**. Indian Army's research in the field of Quantum Technology will help in leapfrogging into next-generation communication and transforming the current system of cryptography in Indian Armed Forces to Post Quantum Cryptography (PQC).

## Science and Technology

- **Genesys International** has launched its pan India program to make the **Digital Twin of the entire Urban India**. The launch programme was inaugurated by **Amitabh Kant**, CEO, NITI Aayog. The creation of this very accurate 3D data will mean a host of applications would open up in high-definition mapping, which was hitherto not possible, for smart cars, e-commerce, logistics, gaming, utilities planning for next-generation networks in telecom, renewable energy and in disaster management and emergency response.
- Nasa-turned-SpaceX flight surgeon, **Anil Menon** is among the 10 latest trainee astronauts who will join the 2021 class of the American space agency as it plans for the first human missions to the moon in more than 50 years.
- **Microsoft** has launched a **cybersecurity skilling program** with the goal of training over **1 lakh learners by 2022** to address the skills gap and prepare India's workforce for a career in cybersecurity. The program is meant to give students hands-on experience with security, compliance, and identity fundamentals.



- The **Indian Space Research Organisation** has signed an agreement with Chinese smart devices maker **Oppe's Indian arm** to strengthen the research and development of the NavIC messaging service. The messaging service is mainly used for broadcasting safety-of-life alerts in areas with poor or no communication, particularly in the oceans. Oppe India has its manufacturing unit in **Noida** and an R&D centre in **Hyderabad**.
- **NASA's Parker Solar Probe** has entered the **Sun's upper atmosphere** for, first time in history. In 2018, launched the Parker Solar Probe aims to unravel the mysteries of the Sun by travelling closer to it. After three years of launching, Parker has finally arrived in the solar atmosphere. Parker Solar Probe has flown through the Sun's upper atmosphere for the first time in history - the corona. The probe sampled particles and magnetic fields there.
- The **Indian Space Research Organisation (ISRO)** has signed six agreements with four countries for launching **foreign satellites during 2021-2023**. About 132 million Euros would be earned through the launching of these foreign satellites on a commercial basis. The ISRO-Indian space agency, founded in 1969 to develop an independent Indian space program.
- **Scientists** have resumed tagging of **Olive Ridley** sea turtles at **Rushikulya rookery** along the Odisha coast, which would help them identify the migration path and places visited by the marine reptiles after congregation and nesting. The exercise was undertaken in Odisha in January 2021 after a span of about 25 years and 1,556 turtles had been tagged.
- **Indian Institute of Technology (IIT) Guwahati** researchers have developed **hybrid pervskite solar or photovoltaic devices** in order to produce electricity from sunlight. These machines are highly efficient and easy to manufacture. According to officials, hybrid pervskite are easily recyclable too.
- **NASA's \$10 billion telescopes James Webb Space Telescope** designed to capture the first glimpse of the universe just shortly after the Big Bang is targeted for blastoff from the **European Space Agency's Kourou, French Guiana**. The revolutionary world's first-of-its-kind space-science observatory of the next decade will capture the earliest galaxies believed to have formed during the early universe's formation.
- **Japan** has launched **Inmarsat-6 F1**, a communication satellite, through a **Mitsubishi Heavy Industries (MHI) H-IIA204 rocket** from Japan's Tanegashima Space Center that will enter geostationary orbit, about 22,240 miles (35,790 kilometres) above the earth. It is developed by the London-based company Inmarsat as a part of its next-generation satellite broadband service. The satellite is 12,060-pound (5,470 kilograms) and is the first of two 'I-6' spacecraft.
- Under the **National Blockchain Project**, Prime Minister **Narendra Modi** has launched blockchain-based digital degrees at the **54th Convocation Ceremony of IIT Kanpur**. Later Prime Minister also inaugurated the completed section of the Kanpur Metro Rail Project and the Bina-Panki Multiproduct Pipeline Project. These digital degrees can be verified globally and are unforgeable.
- The **Texas Children's Hospital (TCH)** and **Baylor College of Medicine (BCM)** announced that Corbevax, a protein subunit Covid vaccine, has received approval from the **Drugs Controller General of India (DCGI)** to launch it in India. The initial construct and production process of the vaccine antigen was developed at TCH's Centre for Vaccine Development.

Currently, the tallest pier bridge record is held by 139-metre high **Mala-Rijeka viaduct built at Montenegro in Europe**.
- The American publishing company **Merriam-Webster** has chosen the word "**vaccine**" as its **2021 Word of the Year**. Merriam-Webster is America's most trusted online dictionary for English word definitions, meanings, and pronunciation. It has been declaring the word of the year since 2008.
- **Kulgam** district administration and the Department of Tourism, **Jammu & Kashmir** organized the **1st ever Aharbal Festival at Kulgam, J & K** to promote tourism in Kashmir, particularly at the Aharbal waterfall. Aharbal falls, also known as "**Niagara Falls**" of **Kashmir**, is a hill station in the southwestern part of Kashmir Valley in the **Jammu and Kashmir**.
- The low-pressure area in the **Bay of Bengal** is expected to intensify into **Cyclone Jawad** which is likely to reach the north **Andhra Pradesh, south Odisha coasts and Some parts of West Bengal**. The storm, once developed, will be called Jawad (pronounced Jowad), as named by **Saudi Arabia**. After **Yaas** in May and **Gulab** in September, this will be the third cyclone headed towards the east coast this year.

- **Ken-Betwa inter-linking of rivers project** has been approved by the Union Cabinet, which is chaired by Prime Minister **Shri Narendra Modi**. At 2020-21 price levels, the overall cost of the Ken-Betwa link project has been estimated at **Rs. 44,605 crore**. The Union Cabinet has approved central support for the project in the amount of Rs. 39,317 crore, which includes a grant of Rs. 36,290 crore and a loan of Rs. 3,027 crore.
- **National Commission for Women (NCW)** has launched a pan-India capacity building programme, '**She is a Changemaker**' for women representatives at all levels, gram panchayats to parliament members and political workers including office bearers of National/State political parties. The programme was launched by Ms Rekha Sharma, Chairperson of the National Commission for Women. To improve leadership skills of grassroots women political leaders.

It also suggested amendments in the brand logo to highlight its origins and protect the product's Geographical Indications (GI) rights.
- Police Commissioner of Delhi, **Rakesh Asthana** has launched an e-learning platform 'Unnati', under the Delhi Police's flagship scheme '**YUVA**' at the **All India Council for Technical Education (AICTE)** Auditorium, New Delhi. Every year, over 1.5 lakh people are arrested by the Delhi Police for various crimes. More than 85 per cent of them are first-timers and only 10-15 per cent are repeat offenders.

- Union Cabinet approved a **Rs 76,000-crore** production linked incentive (PLI) scheme for boosting **semiconductor** and display manufacturing in India. With this, the total amount of production linked incentive (PLI) announced for the electronics sector increase to Rs 2.30 lakh crore.
- Chief Justice of India (CJI) Justice **NV Ramana**, and Chief Minister of Telangana **K Chandrasekhar Rao** has inaugurated India's First **International Arbitration and Mediation Centre (IAMC)** at Phoenix VK Tower at Nanakramguda, **Hyderabad, Telangana**. Those who empanel the centre include internationally acclaimed arbitrators and mediators from countries such as **Singapore and the UK**.
- President **Ram Nath Kovind** inaugurated the reconstructed **Ramna Kali temple in Ramna**, a part of the Bangladeshi capital Dhaka where the landmark **Suhrawardy Udyan** is located. The temple was destroyed by Pakistani forces during their Operation Searchlight in March 1971, the brutal crackdown that led to the genocide & the Bangladesh War of Liberation.
- Union Minister **Rajeev Chandrashekhar** has inaugurated the **MedTech Centre of Entrepreneurship** established at **Sanjay Gandhi Post Graduate Institute of Medical Sciences (SGPGI) in Lucknow**. The center will boost cross-disciplinary application development like medical plus technology in the state. Dr Saurabh Srivastava, former chairman of NASSCOM, the chief mentor of MedTech CoE..
- **Zee Entertainment's** board of directors approved the merger between **Sony Pictures Networks India and Zee Entertainment Enterprises Limited (ZEEL)**, according to a regulatory filing by the media company to the stock. Sony Pictures Networks India (SPNI) will hold a majority stake of 50.86 percent stake in the merged entity.
- **Russia** has launched its first in the series **Project 22220 versatile** nuclear-powered icebreaker known as '**Sibir**'. This icebreaker will support the growing fleet of icebreakers to keep the Northern Sea Route open for year-round shipping through the **Arctic** and enable a wider presence of **India in the arctic region**.

He also received a **Pulitzer Prize ('Sunday in the Park')**, and an Academy Award for the song '**Sooner or Later**'. Also won several awards like eight Grammy Awards, Presidential Medal of Freedom 2015, etc.
- The renowned National Award-winning choreographer and actor, **Shiva Shankar Master** passed away in Hyderabad, Telangana. He was born on 7 December 1948 in Chennai, Tamil Nadu. He was an Indian dance choreographer, worked in South Indian movies. He received the **National Award** for 'Best Choreographer' for the movie '**Magadheera**'.
- The renowned Telugu film lyricist and Padma Shri awardee, '**Sirivennela**' **Chembolu Seetharama Sastry** passed away at the age of 66 years. He was born on **May 20th, 1955** in Anakapalle village in Visakhapatnam district, Andhra Pradesh. He launched his first song in the film, 'Janani Janmabhoomi' directed by K Viswanath.
- Renowned scholar and national professor of Bangladesh Professor, **Rafiqul Islam** passed away. Prof. Rafiqul Islam was one of the greatest scholars on the national poet of **Bangladesh Kazi Nazrul Islam**.
- Former Governor of Tamil Nadu and former Chief Minister of the unified State of Andhra Pradesh, **Konijeti Rosaiah** (89-years) passed away. He had served as MLA, MLC, Lok Sabha members. He held several key portfolios including finance, transport, energy in the cabinets headed by Kotla Vijayabhaskara Reddy, Channa Reddy, and YS Rajasekhara Reddy.



- Veteran journalist **Vinod Dua** passed away recently. He was one of the pioneers in Hindi broadcast journalism, worked with **Doordarshan** to present the youth programme Yuva Manch in the mid-'70s and later with several other television news channels. He was an integral part of NDTV's journey as well. His much-loved food show '**Zaika India Ka**' saw him crisscrossing the whole country just for the best taste.
- Padma Bhushan **Dr Mamballaikalathil Sarada Menon**, India's 1st woman Psychiatrist and the longest-serving head of the Institute of Mental Health has passed away. She was born in a Malayali family in Mangaluru, Karnataka. She was honoured with **Padma Bhushan in 1992 for social works**.
- World's oldest Test Cricketer, former English legend, **Eileen Ash** passed away at the age of **110**. The right-arm seamer made her debut to the national side in **1937 against Australia** and in a career spanning till 1949, she took 10 wickets in the seven matches she played.
- **Chief of Defence Staff (CDS) General Bipin Rawat** has passed away in a helicopter crash near Coonoor in Tamil Nadu. He was among the 14 people who were on board, including his wife and staff members. Thirteen people have succumbed to the crash, including CDS Rawat, **Madhulika Rawat** and 11 others. An **IAF Mi 17 V5 helicopter** with a crew of 4 members carrying the CDS and 9 other passengers met with a tragic accident. Wing Commander **Prithvi Singh Chauhan** was the pilot of the Mi-17V5.
- **Padma Shri awardee** who is a well-known teacher from Odisha, **Nanda Kishore Prusty (Nanda Sir)**, passed away. On 9th November 2021, he was conferred with the **Padma Shri award** for his contributions in the **field of education**.
- Serum Institute of India's Executive Director **Dr Suresh Jadhav** has passed away. He played an important role in the development of the **Covishield vaccine**.
- American gothic-fiction writer **Anne Rice**, best known for **The Vampire Chronicles** novel series, passed away. Anne Rice's debut novel, published in 1976, Interview with the Vampire revolves around a vampire named Louis de Pointe du Lac, who narrates the story of his life to a reporter. - A veteran leader of the Indian National Congress (INC) and the former Union Minister of Textiles, **RL Jalappa** has passed away. RL Jalappa was founder and Chairman of **Devaraj Urs Medical College** in Kolar and RL Jalappa Institute of Technology, Doddaballapur. In 1979 he quit Congress to form the **Karnataka Kranti Ranga** with former Chief Minister D Devaraj Urs and he again joined congress in 1998.
- Former Supreme Court judge, Justice **Girish Thakorlal Nanavati** who headed two inquiry commissions formed to probe into the **2002 Godhra Riots & 1984 Anti-Sikh Riots**, passed away. Justice Girish Thakorlal Nanavati was 86. He was elevated as the Judge of the Supreme Court of India with effect in March 1995 and he retired as an SC Judge in February 2000.
- Pritzker Prize-Winning British-Italian Architect, **Richard Rogers** has passed away at his residence in London, United Kingdom. He received the **Pritzker Prize**, known as the Nobel Prize of Architecture, in **2007**.
- Legendary Malayalam filmmaker **KS Sethumadhavan** has passed away at the age of 90 years. He directed over 60 movies in five languages including Tamil, Telugu, and Hindi during his career.
- **Archbishop Desmond Tutu**, Nobel Peace Prize laureate and veteran of South Africa's struggle against white minority rule, has died aged 90. He was awarded **Nobel Peace Prize in 1984** for his non-violent opposition to apartheid.
- Former England captain, **Ray Illingworth** has passed away. He played 61 Tests for England between 1958 and 1973 and captained the country 31 times, winning 12 matches and an Ashes series in Australia in 1970.
- **Mark Taylor**, artist and toy designer for the **He-Man** and the Masters of the Universe franchise as well as the Teenage Mutant Ninja Turtles, passed away. Taylor began his career with Mattel in 1976 as a packaging designer.

- Veteran Greek politician **Karolos Papoulias**, who served as president at the height of the economic crisis of the 2010s, died. Papoulias, a longtime socialist lawmaker and minister, was close to Andreas Papandreou, the founder of the **Socialist PASOK party**. He served two terms between 2005 and 2015.
- **E.O. Wilson**, the former **Harvard University biologist and Pulitzer Prize winner** whose study of ants and human behaviour made him one of the world's most influential scientists and prompted his calls for action to protect millions of species on the planet, has passed away. He was 92. To protect Earth earned him the nickname "**Darwin's natural heir**".
- Seven-time Rajya Sabha MP from the **Janata Dal (United) & industrialist, Mahendra Prasad** passed away. He was a seven-term Rajya Sabha MP from Bihar and was also elected to the Lok Sabha once. He was first elected to the Lok Sabha on a Congress ticket in 1980.
