#### **Solutions**

#### S1. Ans.(c)

Sol. The SBI Ecowrap report projects India's GDP growth at 7.1% in FY23, in line with the second advance estimates released by the National Statistical Office (NSO) in February.

#### S2. Ans.(c)

Sol. The NavIC system was developed by ISRO to meet the positioning, navigation, and timing requirements of the country, similar to GPS. It provides accurate and real-time navigation services in India and the surrounding region.

# S3. Ans.(e)

Sol. The NavIC signals, particularly the Standard Position Service (SPS), are interoperable with the signals from GPS (United States), Glonass (Russia), Galileo (European Union), and BeiDou (China). This interoperability increases the usability and compatibility of NavIC for users.

## S4. Ans.(b)

Sol. Telangana State has achieved 100% household coverage of banking services under PMJDY, extending them to all sections of the population.
