- (1.1) For posts notified in Level-4 & 5, the candidates having eligibility for Level-2 & 3 may also apply. However, the applicants of Level-2 & Level-3 may be considered against these posts only when none of the applicants for Level-4 & Level -5 are found suitable. In such situation, they will be recruited in Level-2/Level-3 only.
- (1.2) No post is exclusively reserved for any particular community such as OBC, SC & ST etc. However the candidates may enclose self attested photocopies of the communities they belong to.

(1.3) Candidate may also apply for more than one Sports Discipline/Events for which separate application is to be submitted with paying examination fee separately. However, they can not apply for more than one position in the same Sports Discipline/Event.

- (2.1) Persons if appointed as Clerk-cum-Typists have to acquire Typing proficiency of 30 W.P.M. in English or 25 W.P.M. in Hindi within a period of 4 years from the date of appointment. Till such time their appointment to the category will be provisional.
- (2.2) Candidates should possess the requisite educational qualification on or before the closing date of notification. Qualifications achieved after the closing date of notification will not be taken into consideration.
- (2.3) Any relaxation in minimum educational qualification as mentioned above is not permissible.

#### (3.2) Minimum Sports Norms-

#### NOTE-

- (A) For Archery: Participation and medal winning performance in the events organized by the Archery Association of India after 25.11.2020 may be considered for recruitment.
- **(B)** For Basketball: Participation and medal winning performance in the events organized by Basketball Federation of India after 26-07-2017 shall be considered for recruitment. Certificates issued by the Association of Indian Universities and the International Federations for recognized sports achievement in the game of Basketball, will be permissible.
- (C) <u>For Boxing:</u> Sports achievements in the events conducted by the Indian Amateur Boxing Federation or any of its affiliates shall not be considered for purpose of recruitment.

Participation and medal winning performance in the events organized by the Boxing Federation of India after 28.10.2016 may be considered for recruitment.

In boxing discipline, the achievements of players in "Youth" category on or after 25.09.2016 in International Championships will be considered in place of "Junior" category.

- **(D)** For Hockey: Hockey India may be treated as the recognized National Sports Federation for the game of Hockey for the purposes of recruitment.
- (E) All the championships mentioned above should be conducted under the aegis of recognized International/National/ Sports Federations and also recognized by the Railway Sports Promotion Board (RSPB).
- (F) The recruitment is for the minimum of the scale of pay.
- (3.3) Additional acceptable sports achievements/Minimum Sports norms for certain disciplines:

<u>In Athletics</u>: Gold medal winner in Open National Championship (Senior), Inter-State Athletics Championships (Senior) and Asian Championship (Senior) may be considered.

Or

Medal winning performance in National Inter State Senior Athletics Championships may also be considered.

<u>In Badminton and Table Tennis:</u> Sportspersons shall also be considered for recruitment on the basis of their current **Annual All India Ranking** in different Pay Levels as per following criteria:

**Note:** Only the current Annual All India Ranking shall be considered for these purposes. For the purpose the highest ranking may be considered valid for one year for the purpose of recruitment. Ranking in Mixed-Doubles shall be considered only in Badminton and not in Table Tennis.

<u>In Hockey (Men):</u> For recruitment against the posts having Pay Level-2/3; Participation in the International Tournaments (Senior or Junior) of four or more nations may also be considered.

In Hockey (Men) semifinalist in Senior National Championship may also be considered for recruitment in Pay Matrix Level-2/3.

(3.4) For recruitment of sportspersons, on the basis of sports achievements in Junior National championships, the age groups as mentioned below shall only be considered.

- (3.5) Candidates should possess the requisite sports qualification on or before the closing date of notification. Qualifications achieved after the closing date of notification will not be taken into consideration.
- (3.6) Any relaxation in minimum required sports qualification as mentioned above is not permissible.
- (3.7) The certificates of age, educational qualification & sports norms etc attached with application form will only be considered for recruitment. No certificate will be allowed to be added later on.

#### (4) Period of reckoning Sports Achievements-

The Sports achievements of current and previous two financial years will only be taken into account for eligibility. Therefore, the Sports achievement on or after 01.04.2019 will only be considered.

#### (5) Age Limit- (As on 01-07-2022)

- (5.1) Minimum 18 years and maximum 25 years as on 01.07.2022, i.e. must have been born not earlier than 02/07/1997 and not later than 01/07/2004.
- (5.2) No age relaxation is permissible for any category.
- (5.3) The candidate should note that only the 10<sup>th</sup> Standard/Matriculation/Secondary Examination Certificate or equivalent Certificate/Marksheet or School Leaving Certificate indicating Date of Birth will be accepted as documentary proof of Date of Birth.

#### (6) Mode of Selection:

(6.1) Selection is based on total marks obtained by the candidates. The distribution of marks is as under:

(6.2) Trials of the candidates shall be conducted to assess their sports performance and suitability for Railway/Unit team as well as Indian Railways' team. **Trial Committee** shall give its recommendation in terms of either FIT or NOT FIT, for consideration for next stage. The candidates securing minimum 25 marks in trials will be declared FIT and will be considered for next stage of recruitment.

#### (6.3) Selection Procedure:

Selection will be based on performance in sports trials and documents verification to be conducted and finalized by a nominated selection committee. The venue and date for trials, documents verification etc. will be intimated through website only to the eligible candidates. Candidates are advised to visit website regularly for getting all updates. The trials for different Pay Levels may be held separately. Railway administration, South East Central Railway, Bilaspur reserves the right to cancel or modify recruitment process at any stages without assigning reasons thereof.

#### (7) Examination Fees:

- (i) Rs. 500 (Rupees Five Hundred only) for all (except the categories exempted for fee relaxation as mentioned in Para (ii) below), with the provision for refunding Rs 400 after deducting bank charges to those eligible candidates who actually appear in the trials.
- (ii) Rs. 250 (Rupees Two Hundred & Fifty only) for candidates belonging to SC/ST communities, Women, Minorities and Economically Backward Classes (EBC), with the provision for refunding full amount after deducting bank charges to those eligible candidates who actually appear in the trials.
- (7.1) Minorities will mean Muslims, Christians, Sikhs, Buddhists, Jains and Zorastrians (Parsis).
- (7.2) While applying, the candidates claiming fee exemption must submit necessary certificates i.e., SC/ST/Minorities/EBC in the format prescribed.
- (7.3) Economically Backward Classes (EBC) means those candidates whose annual family income is less than Rs. 50,000/- per annum.

## (8) General Conditions (other than specified above):

- (i) The candidates should carefully fill the application form. The Date of Birth, name and initials of the candidate (with correct spelling), Father's name etc appearing in the application form shall tally with the same appearing in school/college certificates/sports certificates & DOB certificate.
- (ii) Please obtain caste certificate (SC/ST/OBC/EBC) in the prescribed proforma from the appropriate authority and produce original at the time of verification. Caste certificates issued by the authorities other than those authorized, will not be considered.
- (iii) Candidate may also apply for more than one Sports Discipline/Events for which separate application is to be submitted with paying examination fee separately. However, they cannot apply for more than one position in the same Sports Discipline/Event.
- (iv) Selected candidate has to pass prescribed medical examination for allotted post. The medical exam will be conducted by Railway medical authorities prior to her/his appointment.
- (v) Candidates belonging to SC/ST communities will be given free traveling authority in second class when called for trials.
- (vi) No Accommodation and TA/DA will be provided while appearing in the selections/ trials. Candidates should come prepared to stay at the place of trials for 2-3 days. They have to bring their own sports kit/equipment and should make their own arrangement for stay.
- (vii) Immediately after closing date for online application, the eligible candidates may be called for trial at very short notice for which candidates should be ready. The call letters will not be sent to candidates separately by post. They will have to visit the website of SECR i.e. <a href="www.secr.indianrailways.gov.in">www.secr.indianrailways.gov.in</a> regularly and download call letter through the given link.
- (viii) Before trials, the identity of the candidates and original documents of age, caste, educational qualifications, sports norms/achievements will be verified by the screening committee/trial committee. Without producing original documents, candidates will not be allowed to appear in trials.
- (ix) No post is exclusively reserved for any particular community.
- (x) Non-fulfillment of any of the criteria mentioned in this notification will make the application liable for rejection for which candidate him/her self will be responsible.
- (xi) Selected candidates are liable to be posted anywhere on South East Central Railway.
- (xii) The selection shall be decided purely on the basis of merit. In case more than one sportspersons score the same marks, preference will be given to younger candidate to decide the merit.
- (xiii) The sportspersons, who can be fitted in the South East Central Railway Sports Association team, will only be considered.
- (xiv) Railway administration reserves the right to alter the terms & conditions/stages of recruitment or cancel part or whole of any recruitment process at any stage without assigning any reason.
- (xv) Sportspersons recruited against sports quota shall be terminated from service if the information and documents furnished by him/her for recruitment are found incorrect/fake at any stage.
- (xvi) Sportspersons recruited against sports quota shall execute a "Service Bond" for a period of 5 years.
- (xvii) Sportspersons recruited against sports quota will undergo probation period of 2 years. The performance of the sports person shall be reviewed before completion of the probation period.
- (xviii) Sports persons having sports norms for higher Pay Matrix level (Grade Pay) and who have applied against the vacancies for the lower Pay Matrix can be considered for recruitment against the Pay Matrix level applied for only. In such cases the sports persons has to give an undertaking that he/she will not claim for higher pay level after joining the Railways, on the basis of sports achievements he/she has acquired prior to joining Railways.
- (xix) The decision of Railway Administration in connection with selection will be final. For non-selection of the candidates no correspondence will be entertained. Canvassing in any form will disqualify the candidate.
- (xx) For any legal dispute, the jurisdiction will be Hon'ble Central Administrative Tribunal, Jabalpur.
- (xxi) Candidates serving in any Central/State Govt. department including Railway or in any Central/State Public Sector Undertaking may apply directly duly informing their employer. However, they will have to produce NOC of their employer at the time of appearing in Trials. Without NOC, they will not be allowed to appear in Trials.
- (xxii) For any further clarification candidates are advised to go through the website of SECR i.e. <a href="https://www.secr.indianrailways.gov.in">www.secr.indianrailways.gov.in</a>. It is also advised that candidate should visit this website regularly for updated information.

(xxiii) The place of posting will be decided by the South East Central Railway administration at the time of offering appointment to the selected candidates.

## (9) Whom/How to apply:

Only **Online application will be accepted.** Candidates are advised to follow the instructions given in "HOW TO APPLY" while submitting online application.

- (ii) Scanned copy of the documents in proof of educational qualification(s).
- (iii) Scanned copy of the documents in proof of sports achievement(s). Sports certificates achieved on or after 01.04.2019 only to be attached.
- (iv) Scanned copy of the documents in proof of caste for OBC-(Annexure-A), for OBC declaration-(Annexure-B), for SC/ST-(Annexure-C), for Minority community declaration (Annexure-D), and for EBC certificate- (Annexure-E).
- (v) Scanned latest colour Passport size photograph of the candidate
- (vi) Scanned signature of the candidate.

Note- The certificates being uploaded should be clear. If uploaded certificates are blur, the application will liable to be rejected.

(11)Invalid applications/Rejections: The applications having any of the following deficiencies/discrepancies/irregularities will be summarily rejected:

- (i) Applications without proper scanned colored photograph (No black and white photo, No photo with side posture, or sunglass or cap to be attached.) Photo should be with white background and with 80% face.
- (ii) Applications without proper scanned signature. Signature should be in running handwriting and should not be in Capital letters.
- (iii) Non fulfillment of Age criteria or Application without proper certificate in respect of Date of Birth as per Para 10 (i) above.
- (iv) Non fulfillment of requisite educational qualification or application without proper certificate in respect of educational qualification.
- (v) Non fulfillment of requisite sports norms or Application without proper certificate in respect of Sports norms.
- (vi) Application without proper certificate in respect of caste (OBC/SC/ST/OBC non creamy layer declaration/EBC certificate/Minority Community Declaration) or certificate not obtained from appropriate authority in prescribed format.
- (vii) More than one application by the same candidate for the same event.
- (viii) Applications sent manually; (not submitted online).
- (ix) Application without prescribed fee as per notification.
- (x) Application without clear certificates attached.
