NOTICE

Assistant Teacher (Nursery) Post Code-88/17 in Directorate of Education.

The DSSSB vide its advertisement No. 04/2017 had advertised **320** {UR-164, OBC-88 SC-42, ST-26 including PH (VH-05, OH-05)} for the post of **Assistant Teacher (Nursery), Post Code-88/17 in Directorate of Education.** The offline examination was held on 02.09.2018.

- 2. Further, on the basis of offline examination of Tier-I, the candidates had been shortlisted for uploading of documents in the e-dossier out of which a total of **173 candidates** (UR-90, OBC-34, SC-40, St-09, PH/OH-04, PH/VH-01), **08 candidates** (UR-03, OBC-04, ST-01), 05 candidates (UR-02, OBC-01, St-01), **05 candidates** under SC category were found provisionally eligible as per documents uploaded in support of educational qualification, age etc. in accordance with advertisement No. 04/2017 and RRs for the post of Assistant Teacher (Nursery) Post Code-88/17 and were provisionally nominated vide Result Notice No. 442 dated 24.05.2019, Supplementary Result Notice No. 539 dated 31.10.2019, Supplementary Result Notice No. 570 dated 23.12.2019, Supplementary Result Notice No. 607 dated 27.02.2020, Supplementary Result Notice no. 691 dated 13.10.2020 & Supplementary Result Notice No. 720 dated 27.11.2020 respectively for the post of Assistant Teacher (Nursery), Post Code-88/17 in Directorate of Education.
- 3. However, after declaration of Main Result, the User Department has returned a total of 03 dossiers under SC category before expiry of extended waiting panel in this post code and in replacement of same only 01 candidate is available in the merit list as all the candidates in waiting panel have been considered.
- 4. Therefore, to fill up remaining vacancies under SC category, it was decided to call the edossiers of the qualified candidates of offline examination conducted on 02.09.2018 below the last shortlisted candidate under SC category as the qualified candidates are still available in this category only. Accordingly, the merit list has been lowered to call the e-dossiers of the below mentioned candidates subject to attaining the minimum qualifying marks and correctness of the information furnished by the candidates in their application form:-

6. The category wise cutoff marks for uploading e-dossier have been given as under:-

- 7. The link for uploading of e-dossier shall be kept open for a period of 15 days w.e.f. 23.03.2021 to 06.04.2021 only for the above candidates shortlisted under SC category.
- 8. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria as on the cutoff date, i.e 31/01/2018. The shortlisted candidates are also being separately informed through SMS & E-Mail on their registered mobile number & e-mail id. If, any candidate fails to upload the e-dossier during the above said period, his/her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground.
- 9. THE LINK FOR UPLOADING OF E-DOSSIER SHALL BE OPENED ONLY FOR THE ABOVE SHORTLISTED CANDIDATES UNDER SC CATEGORY W.E.F. 23.03.2021 to 06.04.2021.
- 10. Mere asking the candidate for uploading documents in the e-dossier module does not confer him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above she will not be given any further opportunity and his/her candidature will be treated as cancelled.
- 11. While every care has been taken in preparing the list of shortlisted candidate, DSSSB reserves the right to rectify errors and omissions if any, detected at any stage.
